### SIDEWALK REPAIR CRITERIA

- Repair areas may include sidewalk, driveway approach, curb and gutter, and/or parkstrip located adjacent to property.
- Repair criteria includes:
  - Vertical separation of more than one-half (1/2) inch.
  - Ramping: rise or depression of more than one (1) inch within eight (8) inches, in conjunction with a vertical separation.
  - Hole or opening in a break or construction joint of one (1) inch or more.
  - Breaking away, spalling, or chipping of concrete with a depth of more than one-half (1/2) inch.





## **INITIAL SIDEWALK REPAIR NOTICE**

- Sidewalk repairs may include curb, gutter, driveway approach, and/or parkstrip area
- State law (<u>Streets and Highways Code, Chapter 22 of Division 7, Part 3</u>) and San José Municipal Code (<u>Section 14.16.2200</u>) place responsibility of sidewalk repairs with the adjacent property owner
- Department of Transportation generates a repair notice after inspection determines repairs are needed
- Inspections conducted as the result of community requests and City staff field observations





### SIDEWALK REPAIR ACTIVITY

- Vast majority of sidewalk repairs are completed and resolved successfully
- Proposed liens are for property owners who have not reimbursed the City for the expenses associated with City contractor repairs
- FY 2024-2025 Sidewalk Repair Activity (through May 8, 2025)
  - 5,296 sidewalk repairs completed
    - \* 68% of repairs completed by property owner
    - \* 32% of repairs completed by City contractor
  - 3,606 property owners completed sidewalk repairs using their own contractor
    - \* ~\$245.5K in Sidewalk Repair Inspection Fees
  - I,690 properties were serviced by City Contractors
    - \* ~\$185.9K in Sidewalk Repair Inspection Fees
    - \* ~\$1.43M advanced from the General Fund to repair sidewalks



#### FINANCIAL HARDSHIP PROGRAM

- FY 2024-2025 Hardship Budget (through May 8, 2025)
  - Transportation received 289 requests for sidewalk hardship and approved 124 properties (~\$391K)
  - In FY 2023-2024, Transportation approved 74 properties for hardship (~\$282K)
- Eligibility is based on income guidelines set forth by the U.S. Department of Housing and Urban Development, in accordance with Area Median Income (AMI):

### **REPAIRS PROCESS OVERVIEW AND TIMELINE**

- Sidewalk Repairs and Noticing (August October)
  - 3 Repair Notices, including a brochure (with hardship information) and property door hangar, are sent to property owner over a 3-month period
  - If the property owner has not completed the repair work, the City contracts to complete the repair(s)
- Invoicing, Payment and Delinquency Process (November March)
  - After the repair work is completed, Department of Transportation issues an invoice with an amount due and payment due date
  - If payment is not made by the due date OR the property owner has NOT entered into an agreed-upon payment plan, Finance sends 30-day, 60-day, and final notices
- Lien Process (March August)
  - $\checkmark$  City Council approves a memorandum to set a public hearing for the cost of sidewalk repairs
  - $\checkmark$  Transportation sends two notices of intent to lien to delinquent property owners
  - $\checkmark$  Transportation hosts administrative conference(s) for property owners to discuss their bill(s)
  - City Council holds a public hearing to record liens on properties for the reimbursement of repairs
  - □ Special Assessment is placed on the Santa Clara County Secured Property Tax Bill





#### CITY COUNCIL APPROVAL TO SET PUBLIC HEARING


- On April 15, 2025, City Council approved a memorandum to set a public hearing for the cost of sidewalk repairs on June 17, 2025
- The memorandum was coordinated with the Department of Transportation, the Office of the City Attorney, and the City Manager's Budget Office
- The memorandum included the schedule to file sidewalk repair liens on delinquent properties:

### **DELINQUENT SIDEWALK INVOICES PENDING LIEN**

- 99 Delinquent Sidewalk Repair Invoices
- Sidewalk Repair Fees: ~\$248.5K
- Delinquency Fees: ~\$42K
- Lien Fees: ~\$16.5K
- Total:~\$307K
- Average Invoice Balance: ~\$3K
- Average Invoice Age: ~545 Days







### RECOMMENDATIONS

- a) Conduct a public hearing on recording liens on properties for the reimbursement of the cost of sidewalk repairs;
- b) Adopt a resolution confirming the Report from the Director of Finance concerning the delinquent sidewalk repair costs and the assessments contained in the report, and;
- c) Direct the recording of liens and the placement of charges as set forth therein on the 2025-2026 Santa Clara County Secured Property Tax Bill for the cost of sidewalk repairs.
