## **RECOMMENDATION**

1. Approve the staff-recommended action with the following additional direction to:

a. Prioritize the completion of the agreement between the City and History San José with respect the relocation of the Sakauye Farmhouse to History Park; and

b. Facilitate the acquisition of funding for the relocation of the Sakauye Farmhouse to History Park.

## **BACKGROUND**

On August 13, 2024, the City Council approved a Planned Development rezoning at 0 Seely Avenue,<sup>1</sup> entitling a project allowing for the construction of a new mixed-use neighborhood including roughly 1,500 much-needed new homes and a 2.5-acre neighborhood park. This project approval occurs at a time when the *actual* construction of new multifamily housing is vanishingly rare in San José. At the time, the site hosted a functioning farmstead, historically owned by Eiichi Sakauye and his family. My office submitted a memo noting the historic contributions of Eiichi Sakauye and the relevance of his family farmstead as one of a tiny handful of properties in California to which a Japanese-American family had successfully

returned after the Second World War era internment and dislocation of this community.<sup>2</sup> Council discussion of the item underscored a desire to find a means to preserve the Sakauye farmhouse ("Farmhouse") as a symbol of this difficult history for future generations, either as part of the planned neighborhood park or by moving the Farmhouse to History Park.

After consultations with the Sakauye family and the broader Japanese-American community in Silicon Valley, a general consensus emerged in favor of moving the Farmhouse to History Park and restoring it there. Based on estimates provided to the administration and History San José, the total cost of such a move is expected to reach \$750,000. Thus far, the project proponent, Hanover, has moved the Farmhouse from its original location to a secure space on the development site at 0 Seely and has successfully deconstructed portions of the structure and certain of its outbuildings. History San José has likewise successfully raised upwards of \$400,000 in donations to support the move. Still, a gap of upwards of \$350,000 remains to safeguard this special symbol of our community's history. The deadline to move the Farmhouse off-site now looms: November 2025.

For these reasons, I ask my colleagues to join me in directing staff to prioritize the final steps in moving the Farmhouse to History Park: completing an agreement on the relocation and funding between the City and History San José,<sup>3</sup> and facilitating the acquisition of the remaining funding.
