Dear San Jose Redistricting Commission,

Equality California, the nation’s largest statewide LGBTQ+ (lesbian, gay, bisexual, transgender and queer) civil rights organization, would like to express our support for the Unity Map, which best unifies and empowers our local LGBTQ+ community and the diverse communities to which we belong. We have been closely following the redistricting process to ensure that our identities are respected as a community of interest given our lived experiences and culture that bring us together both as residents and as voters in the City of San Jose. We believe we need to do more than balance populations; we need to unify and empower our local communities.

In the City of San Jose, there is a geographically significant LGBTQ+ community of interest residing along The Alameda, SOFA district, and surrounding areas of Downtown. The Unity Map best brings together this region into one district, ensuring that the critical community of interest can identify and support candidates of choice who reflect their values and will fight for their community’s unique needs. Furthermore, the Unity Map’s electoral lines take a bold step of effectively creating two Downtown districts with the intention of preserving Communities of interest—not just for our LGBTQ+ community, but for many of our other working families who face tremendous challenges in San Jose. Thus, we see the significant community support for the Unity Maps among community organizations such as Asian Law Alliance, NAACP Silicon Valley, the La Raza Roundtable, and the Latino Leadership Alliance.

Equality California has been tirelessly advocating for the LGBTQ+ community in California and has routinely uplifted how redistricting efforts will have a lasting impact not just on LGBTQ+ representation, but also on LGBTQ+ civil rights and protections across the country and at every level of government for the next ten years. 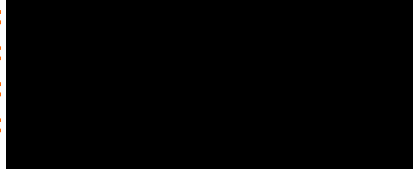
and help us unify and empower our local LGBTQ+ community so that we may continue to protect our community, our civil rights, and our ability to elect candidates of choice.

We were heard, respected and well represented at City Hall by our council member. Former CM Khamis and current CM Mahan are great examples. A move to District 2 will great diminish our voice. Its been silenced in the past. Without representation former CM Khamis and current Mahan our voices would never have been heard.

As a former neighborhood commissioner, and current Measure T Oversight committee member I'd have a solid feel for residents beliefs. I definitely have a solid understanding of each of your districts from my interactions with commissioners. Dear Mayor and City Council,

As a long-time San Jose resident and proud gay man (attending my first San Jose Pride event in 1994), I have been an advocate for equal rights for everyone and the freedom to live anywhere in San Jose. I have the expectation that I will have a voice and be fairly represented no matter where I live; including any district.

Equality California Institute, with Los Angeles headquarters and none in San Jose, does not speak for me. I cannot condone reverting back to segregation in any form including oddly “packing” people into a certain district to be heard. *It can be a difficult step to move from a community formed by the fight for equal rights to a larger community for the benefit of ALL.* We should embrace the progress made and build on it in a positive way. The efforts of the LGBTQ+ movement must be one of inclusion not separation.

The final map should be based on the redistricting guidelines. The Community Map (and also the Commission Map) takes the current district map and makes changes based on population and community input while keeping neighborhoods and established communities together. The Unity Map doesn’t achieve this balance for every area, at best stretches the redistricting principles and is actually divisive. I challenge the council to remove this controversial map from consideration.

Please support the Community Map and FAIRNESS for ALL. I am happy to be an equal part of my already diverse/embracing neighborhood and of the larger community throughout San Jose.

On behalf of the San Jose Downtown Association, we are submitting this letter to share our support and request for Council to adopt the Community Map for city redistricting boundaries.

Over the last several weeks, we have heard from downtown residents, business and property owners, and community leaders that there is a strong desire to keep downtown neighborhoods cohesive and within one council district. Moreover, we have heard public comment at several Redistricting Commission meetings that council districts adjacent to downtown commented similar sentiment, all of which the Community Map captures best.

At the November 17 Redistricting Commission meeting, the Commissioner map was unanimously voted to move to council; Community Map 5.0 was recommended by a 9-2 vote; the Unity map was narrowly forwarded by a 6-5 vote.

We thank the Redistricting Commission and Redistricting Partners for dedicating several long nights to this very important topic which will help form the future growth of San Jose. As discussed by the commission, we must keep our city's neighborhoods and business districts intact and the Community Map accomplishes this goal.

Thank you for your consideration and leadership during these turbulent times.

Dear Mayor and City Council,

Our neighborhood residents came out in numbers for the Redistricting Commission meetings with letters, speakers and a Community of Interest presentation to keep the Vendome with District 3 and to keep the downtown neighborhoods together.

The Vendome is a very small neighborhood (approximately only 9 blocks long-(from Taylor to Ryland/Bassett Street) by 2 blocks wide-(from the 87 freeway to N. 1st Street). It is mainly the former property of the Vendome hotel and includes apartment complexes, two condominium complexes and many historic homes and duplexes.

On the west side is the 87 freeway, the Guadalupe River, Guadalupe Park, a shopping plaza, and a railroad. These natural and artificial boundaries separate us from the Rosegarden/Willow Glen-District 6.

On the north side are the old county buildings including the county jail, a tiny home village and another upcoming project for the unhoused in the police parking lot.

On the east side is the N 1st Street Urban Transit Village-which is in the final planning stages, the Japantown-Ayer light rail stop (the second stop from Santa Clara street) and our adjacent neighborhoods of Hensley and Japantown.

This illustrates the unique placement of our neighborhood including the natural boundaries, separation from District 6 and our close proximity to the downtown.

The Vendome is carved out from downtown into another district in the Unity Map. At one meeting it was orally stated that it is planned to shift the line to San Pedro which is almost worse as it would actually divide our small neighborhood and isolate a small number of homes/residents.

We would also prefer to keep our adjacent neighborhoods whole and together as this map splits downtown into different districts around Japantown.

It seems strange that some districts are majorly changed while others remain intact. It would really help if the Unity Map presenters could re-explain their formula and particularly explain their reasoning behind the deviations from the current district mapping and their purpose for splitting District 3.

The Community Map keeps the Vendome whole and connected with our adjacent downtown neighborhoods. Similar to the Commission Map, it starts with the current district map and makes changes based on population and community input. In addition, the Community Map was created from a grassroots neighborhood effort and has tried to reach out to the various neighborhood associations and residents for feedback. It also complies with the redistricting guidelines. We find the Community Map to be the fairest/best option, for our neighborhood and the city.

We engage regularly with representatives from Northside, Hyde Park, Japantown, Hensley and other downtown neighborhoods on various city government and neighborhood concerns, objectives and improvements.

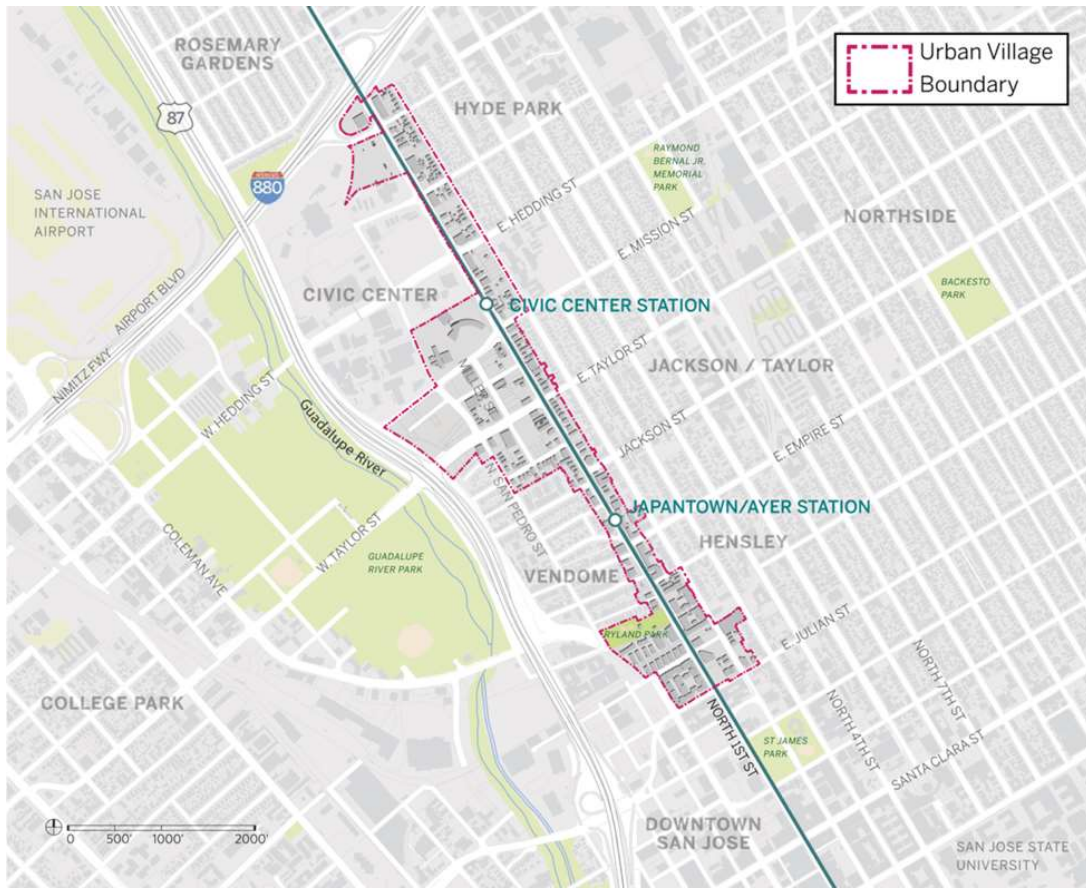

We also share a love of preserving our city's history through architecture and renovation of historic homes and have generally formed a community with our adjacent and nearby neighborhoods.

We clearly hear all districts advocating to not be majorly broken up. That is what we are asking for too. **Please support the Community Map as it keeps the Vendome and downtown within District 3 and bigger picture-keeps the downtown whole and together.**

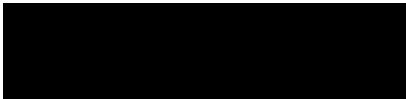

Dear Mayor Liccardo and City Council,

In order to ensure democracy thrives in San Jose, we need to make certain all of our voices are heard. Unfortunately, across the nation we continue to see efforts to disenfranchise Black, Brown and Asian voters. The city of San Jose needs to take this opportunity to stand against voter suppression.

Since the districts we draw this year will shape our lives and communities for the next decade, it's vital that we choose a map that is truly representative our diverse community. For this reason, I am writing in favor of the Unity Map submitted by South Bay Labor Council, the San José/Silicon Valley NAACP, Asian Law Alliance, La Raza Roundtable, Latino Leadership Alliance, and Silicon Valley Rising. It was created by civil rights and community-centric leaders with years of experience living in San Jose.

The Unity Map keeps the neighborhoods and communities of San Jose whole, including Fruitdale, the Rose Garden, College Park, Penitencia, Alum Rock, Berryessa, Evergreen, Silver Creek, Naglee Park, Little Saigon, Communications Hill, and Seven Trees. It was drawn with each of these Communities of Interest in mind. It remains compact, with easy to identify, whole districts, while also working with San Jose's unique boundaries and their intersection with Unincorporated County Land. It also promotes fairness, ensuring that ethnic coalitions have an equal vote in their district and conforms to the Fair Maps Act and the California Voting Rights Act. With its approval it will empower the Black community, which has already been devastated by displacement, and ensures better representation of our Asian and Latinx populations.

The Unity Map **increases the representation** of Latino, Asian and Black residents and renters significantly, by about 1.5% per a district, especially in important districts like D2 and D6, while preserving majority-minority AAPI seats in D4 and D8 and heavily Latino influenced districts in D7, D3 and D5. It also **bonds** multi-family neighborhoods along the I-85 corridor, like Hoffman Via Monte that have been poorly represented in the past; we're giving working families and communities of color, who rely on rental housing, a chance for leadership better representing their needs.

Listed as one of the top 10 most livable cities in America by [SmartAsset](#), the City of San Jose needs to reflect all our voices, no matter who we are, what we look like, or how much money we have. By voting for the Unity Map, you are ensuring that typically marginalized communities are recognized and their vote is not diluted.

This letter was prepared by the Silicon Valley Council of Nonprofits, in consultation with the Race Equity Action Leadership (REAL) coalition. The REAL community of nonprofit leaders and allies has been meeting since June 2020 to use our positional power to advocate for a more racially-just and equitable society; to establish a peer network of leaders committed to fighting white supremacy and systemic racism in ourselves and our institutions; and to hold each other accountable to the promises we made in the [Nonprofit Racial Equity Pledge](#). The REAL coalition is broadly representative of the nonprofit community including human and community services, mental health and health, arts and culture, domestic violence, services for older adults, food distribution, education, environmental, farming, legal, disability rights, LGTBQ rights, ethnic, immigrant rights, housing and homelessness, criminal justice reform, urban planning, intermediary organizations, and others. Over 120 organizations have participated in the REAL coalition.

As a coalition of nonprofits and allies working towards racial justice, we support drawing San José's electoral district boundaries in a manner that does not suppress the votes of Black, Latinx, Asian, and Indigenous residents. The "Unity Map," created by a local coalition, is currently the only map that does not suppress the unified voices of people of color, who have been historically underrepresented.

We urge you to forward to the City Council only electoral district maps that protect the unified voices of San José's communities of color.
