Methodology

All data was collected from RMS. The data was collected for the first 15 weeks of the 2020 Shelter in Place mandate, and the equivalent dates in 2019 for comparison.

Consistent with previous Domestic-Related Incident products, the data is presented and organized by OCCURRENCE DATE, though the data was pulled by REPORT DATE. This allows the reader to analyze when crimes were occurring, rather than when they were reported, while focusing on crimes that were reported to SJPd during the Shelter in Place Mandate.

Key Data Considerations

Data reported in June of 2020 is preliminary, and is subject to change pending UCR submission.

Some data cells indicate NC or non-calculable, indicating that a percentage comparison cannot be made. Domestic related reported incidents contained in this report do not exclude unfounded incidents.

Summary

The following analysis examines trends of Domestic-Related Reported Incidents during the 2020 Shelter in Place from 3/15/2020 - 6/27/2020 and compares the reporting statistics to those for the same time period from 3/15/2019 - 6/27/2019. **Reported domestic-related incidents have decreased by 2% in 2020 compared to the same time period for 2019.** The attributes on the following page were examined for trends. **The following analysis shows that 2019 and 2020 data do not reflect a significant difference from one another.** No trends in occurrence were noted during previous analyses of Domestic-Related Incidents during Shelter in Place.

Recommendations:

- Opportunity for community intervention at [REDACTED] Blossom Hill Rd.
- Evaluate opportunities for potential community remedies or Crime Prevention Unit interactions in District R and District W, who experienced the largest increases in domestic related incidents.

Analyses

Division/District: This analysis is contained on pages 3-5. Southern and Central districts both increased domestic-related reported incidents while Foothill and Western Divisions experienced decreases in reported incidents. District W experienced the highest increase in reported incidents, increasing by 75%, despite Foothill Division decreasing reported incidents by 4% overall. District R increased reporting by 53%, and District X increased reporting by 25%. District F was the only Western Division district to experience an increase in reporting.

Location Type Description: This analysis is located on page 6 & 7. Trends in location type remain relatively unchanged. Most incidents occur in a home/residence or on a street/road/alley/highway.

Location: This analysis is contained on page 8. Addresses of these top locations represent repeated visits to the same location, or multiple instances of domestic violence in the same location at different times. While sorting by address does not confirm the same entities are involved in each reported incident, it provides an overview of where SJPD officers are most frequently responding. Out of 648 reported locations, 8 locations (~1%) were reported four or more times (excluding unknown incident locations). Please refer to page 7 for these locations.

Incident Type Description: Incident Type Description analysis is contained on pages 9 & 10. The top domestic-related incidents remained the same between 2019 and 2020: 273.6A PC DV RESTRAIN ORD VIOL (388 in 2020 and 424 in 2019), 243(E)(1) PC BATTERY DOMESTIC (216 in 2020 and 291 in 2019), and 273.5(A) PC DV SBI OR WEAPON (107 in 2020 and 114 in 2019). All three of these most common incident types decreased in 2020 compared to 2019. However, numerous domestic-related incidents did not occur in 2019 that were reported in 2020 or increased significantly. In 2020, patrol officers received training in the usage of more specific domestic-related offense types that can explain the sharp increases in variety of domestic-related offenses.

Time of Day: This analysis is contained on pages 11 - 13. No difference trends in time of day in which the incident occurred were identified. General increases in occurrence for both 2019 and 2020 remain between 21:00 and 00:00 hours, decreasing from 01:00 to 07:00 hours.

Day of the Week: This analysis is contained on pages 14 & 15. Reported incident dates increased over weekend days (11% on Saturdays and 13% on Sundays) while reports on Fridays most notably decreased by 28%.

Report Date Compared to Occurrence Date: This analysis is contained on pages 16 & 17. The proportion of reported domestic-related incidents reported on the same day, within a week, within a month, within a year, and within 5 years remained approximately the same in 2019 and 2020. Seven of the 15 analyzed weeks showed more same-day reports of a domestic related incident in 2020 than in 2019. Seven of 15 weeks also showed more reported incidents within 1 week of occurrence in 2020 than in 2019.

These statistics are sourced from the San José Police Department's records management system. They are not used to report to the FBI's Uniform Crime Reporting (UCR) Program and therefore should not be compared to the UCR submitted statistics. This report is run by the dates the crimes are reported and statistics may be subject to change due to the reclassification or unbounding of crimes.

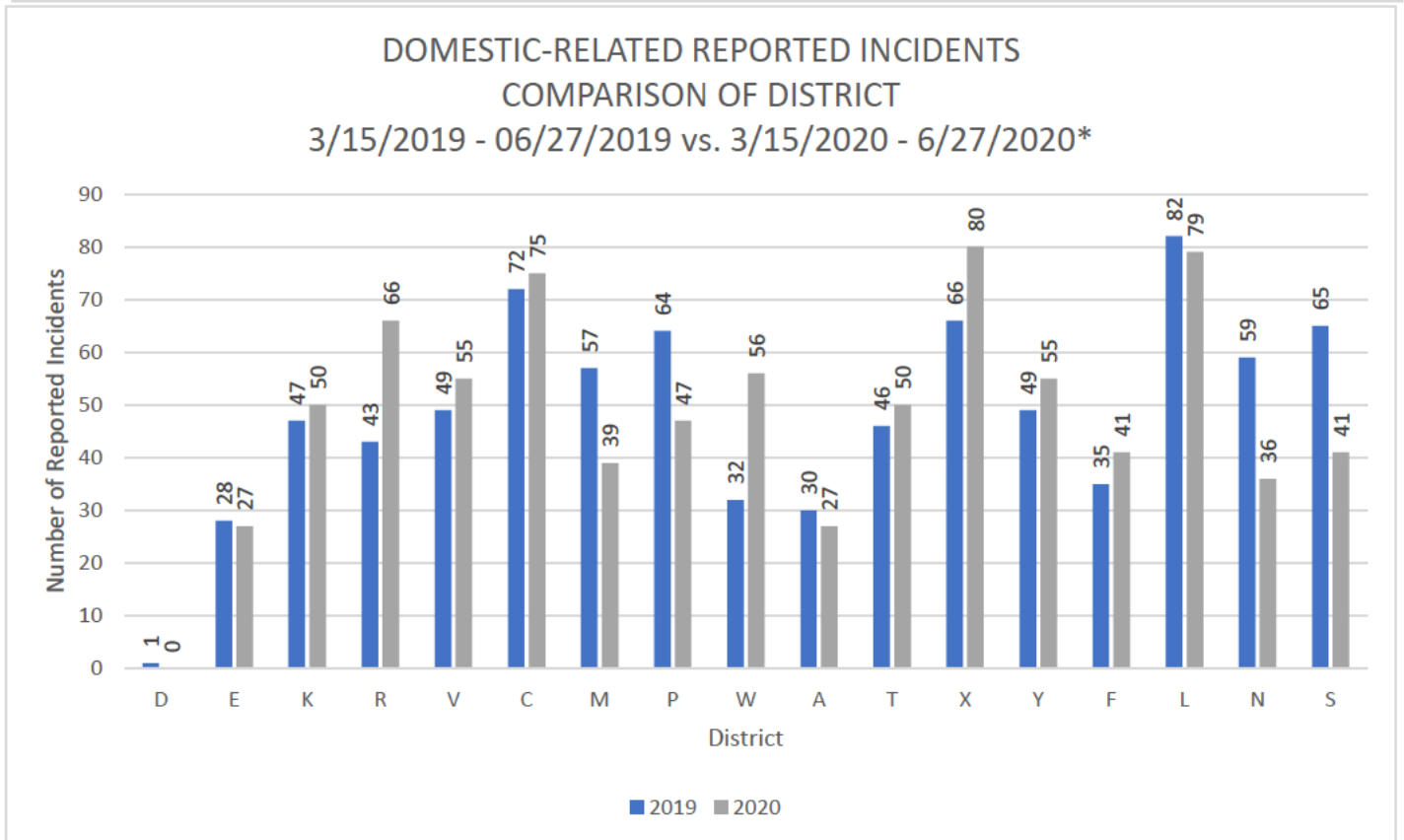
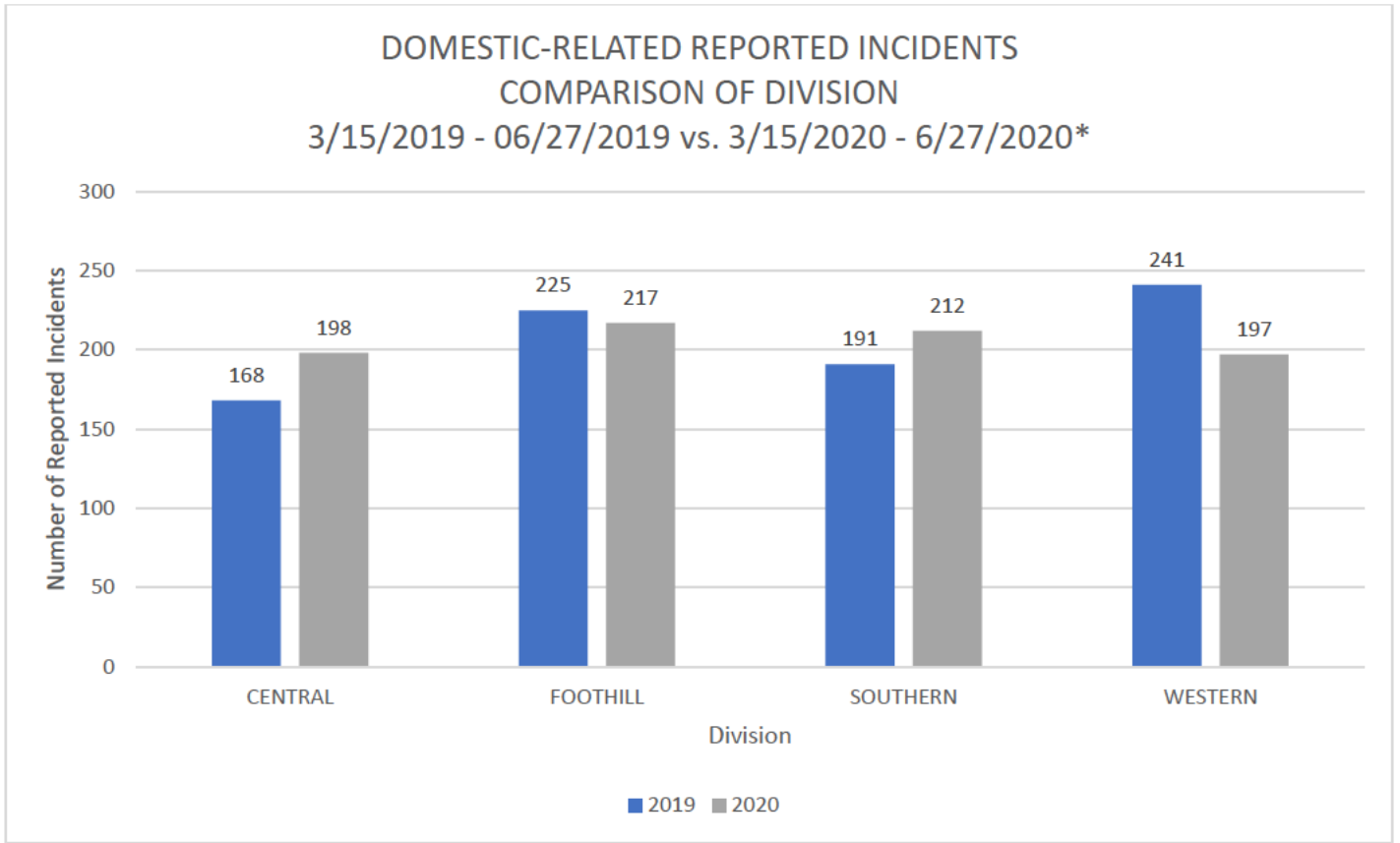
