

Good evening, All,

Thank you again for your patience and for continuing to raise these concerns. I
fully understand how disruptive this situation has been for your neighborhood
and local businesses, and I want to assure you that we are committed to
addressing it as best we can.

After speaking with Councilmember Batra, we have arranged for officers to be
sent out to Las Colinas to assess the RV situation. These officers will be
working on overtime to ensure the issue is addressed promptly. We will be
orange-tagging the vehicles to move and issuing citations for any vehicle code
violations. However, I want to be transparent about a significant obstacle we are
facing: towing companies are currently refusing to tow oversized vehicles due to
the high costs involved in towing and disposing of them. This means we are
unable to remove the RVs as quickly as we would like.

Additionally, the recent influx of RVs to Las Colinas is likely due to our recent
activity asking RVs to move off Realm Drive, which is in the same general area.

We are working closely with the City Manager's Office and the towing vendors
to find a resolution, but in the meantime, we are launching an Oversized Vehicle
Regulation Pilot Program. This program will establish temporary tow-away
zones in the areas most affected by the presence of oversized and lived-in
vehicles, allowing for trash cleanup and street sweeping.

I also want to acknowledge the comparisons made to actions taken in other
Council districts. It is important to recognize that each area of San Jose is
unique, with different challenges and dynamics. What may have worked well in
one district may not be as effective in another due to variations in population
density, neighborhood layout, and the specific needs of the residents and
businesses in the area. We are committed to finding solutions tailored to the
unique circumstances of Las Colinas and surrounding neighborhoods. Our
approach is designed to meet the specific demands of your community, and we
appreciate your understanding as we work through these complex issues.

I know this is not the immediate solution you were hoping for, but I want to emphasize that this issue is a priority, and we will continue enforcing what we can while working toward a longer-term resolution. Your engagement and patience are greatly appreciated.

How did the area on Mt Pleasant Rd and Ocala get taken care of? I personally spoke to one intern in the District 8 office and was told that you all were working diligently on taking care of that situation and it is now all cleared. I will say I am the one who gave out the email addresses to the homeowner's at the Terrace Hills HOA because there vehicles and homes were being broken in to due the people from the RVs jumping the fences or they were jumping the fences to go in to the HOA swimming pool. I am in that neighborhood frequently and it is now staying clear from all of the vehicles parking where they were. I have spoken to colleagues that live over there and they have informed me that there has been two occasions when the trailers or vehicles have returned and someone shows up and they move immediately. The company I work for manages this HOA and also one off of Santa Teresa Blvd where the RV's are also parked.

I think you missed the KUDOS to District 8 for getting things done. Please take the compliment it's well deserved. We are just asking for the help on Las Colinas and in the District 10 area that we have been asking for for over 3 years. The two hour parking needs to be enforced by everyone who is parked on Las Colinas. The police department has not been out here for awhile, neither has parking enforcement.

We are filing up weekly in neighborhoods and business streets. Totally out of control.

Waiting for 3 years to get a bunch of trailers off our street, and now they are all coming back.

Maybe Dist 2 and 10 need some help. Don't you all work for the mayor?

You must be doing something way different then our leaders here are. The people in these areas, Bernal, Las Colinas, Vista Park, Chenoweth, and Lean areas are full. They are in front of homes. On both sides of the street. If you don't have that, then your doing something different then our city official. Or its not evenly supported to clear it out.

Which ever it is, it appears you have it more under control then we do here.

Maybe work together and come up with some solutions, to help the whole area, not by districts.

But I think 3 years is uncalled for. And that's not even the encampments, tents, homeless, and drug addicts and vandals.

Being asked for money every time you run to the store, get gas, go to the cleaners.

Just about anything now. On corners, while you wait at a light.

We need to get a hold on this, and I don't think were asking for too much.

Maybe talk to our officials and see what they can do better. This is not working.

This is documented now so if something goes wrong it's on all of you because you let this get to this point. Government shouldn't be this slow. It will even cost more as time goes on. Why not fix it now, so they see that we are towing and they can't occupy areas that they shouldn't be in. They are in control because the city isn't doing anything about it. They are being confronted by homeowners, and soon this will be a big problem. Someone will be hurt. These trailers have been ticketed elsewhere, you can find that out, send them back to where they came from. If it is the fairgrounds, then send them back there. Someone there is telling them to come here.

Take control before homeowners do.

Why is the city always behind what is happening. You all get paid to do this job, now do it. There certainly is a lot of you in the mayors office, I get notes from about 20 different city people. That's your job. Doing nothing is not an option now. This whole area in South San Jose is filthy dirty, Homeless on the streets, stealing, begging, encampments, trailers, drug addicts. And more are coming weekly. This is not how we live. We live in a civilized city, and you all have ruined this area from not doing your jobs.

Don't put them here, we have enough to deal with. We are unable to handle what is here now. Families have to explain this to their kids when they walk to school, when they see buckets on their curbs for human waste, weapons, gangs, fights, stealing.

This is not in your neighborhood. You wouldn't allow it.

Barbara,

Thank you for reaching out and for your candid feedback. I fully understand the frustration you've expressed, particularly regarding the long-standing presence of RVs and encampments in areas. I want to assure you that the City is working to address these issues, but I also want to acknowledge the challenges we are currently facing. The Police Department will continue to get officers out there when they can to be a presence and address any concerns regarding criminal behavior. BeautifySJ will continue to service the location to improve and maintain cleanliness in the area.

One of the biggest obstacles in resolving the RV situation is the limitations with towing. While you are right that enforcement, such as ticketing and towing, is critical, the reality is that towing companies are currently refusing to tow oversized vehicles due to the high costs associated with towing and disposing of them. That said, we are working closely at the City Manager's Office and with the Police Department, the Department of Transportation, and towing vendors to find a solution. This is a top priority and we will be sure to share more information as we continue to get closer to a solution.

We've recently launched the beginning of the [Oversized Vehicle Regulation Pilot Program](#), which aims to create temporary tow-away zones and enable more effective street cleanups. While this won't solve everything overnight, it is a step toward the more consistent enforcement you are calling for.

Please know that your concerns are being taken seriously and we are working to improve the situation. I understand how this is impacting your neighborhood and businesses, and we will keep pushing for solutions that not only address the immediate issues but move towards ending the homelessness crisis. Thank you again for your continued engagement. Please feel free to reach out with any further questions or concerns.

Good evening, All,

Thank you again for your patience and for continuing to raise these concerns. I fully understand how disruptive this situation has been for your neighborhood and local businesses, and I want to assure you that we are committed to addressing it as best we can.

After speaking with Councilmember Batra, we have arranged for officers to be sent out to Las Colinas to assess the RV situation. These officers will be working on overtime to ensure the issue is addressed promptly. We will be orange-tagging the vehicles to move and issuing citations for any vehicle code violations. However, I want to be transparent about a significant obstacle we are facing: towing companies are currently refusing to tow oversized vehicles due to the high costs involved in towing and disposing of them. This means we are unable to remove the RVs as quickly as we would like.

Additionally, the recent influx of RVs to Las Colinas is likely due to our recent activity asking RVs to move off Realm Drive, which is in the same general area.

We are working closely with the City Manager's Office and the towing vendors to find a resolution, but in the meantime, we are launching an Oversized Vehicle Regulation Pilot Program. This program will establish temporary tow-away zones in the areas most affected by the presence of oversized and lived-in vehicles, allowing for trash cleanup and street sweeping.

I also want to acknowledge the comparisons made to actions taken in other Council districts. It is important to recognize that each area of San Jose is unique, with different challenges and dynamics. What may have worked well in one district may not be as effective in another due to variations in population density, neighborhood layout, and the specific needs of the residents and businesses in the area. We are committed to finding solutions tailored to the unique circumstances of Las Colinas and surrounding neighborhoods. Our approach is designed to meet the specific demands of your community, and we appreciate your understanding as we work through these complex issues.

I know this is not the immediate solution you were hoping for, but I want to emphasize that this issue is a priority, and we will continue enforcing what we can while working toward a longer-term resolution. Your engagement and patience are greatly appreciated.

Addendum to my scoping comments: Coyote Valley has long been the home of lush farmland and vast open space that is a crucial water resource for Silicon Valley, it being a recharge area for the water table that provides water to San Jose. It's a floodplain that absorbs water and protects San Jose from extreme flooding events. It is home to wildlife, including endangered species. San Jose passed Measure T in the November 2018 election, approving up to \$50 million for land acquisition and preservation in Coyote Valley.

Measure T provided an innovative infrastructure bond that has served to protect San Jose's "green infrastructure" in Coyote Valley, as well as invest in disaster preparedness, public safety, and other infrastructure in the city.

Voting yes on Measure T provided a range of benefits including:

- Having flooding occur in Coyote Valley instead of in the urban areas of San Jose.
- Having carbon stored there instead of emitted in the atmosphere.
- Having San Jose retain its value for wildlife and urban edge agriculture, as well as for wildfire protection.

Dear San Jose City Council,

Protect Our Parks. We ask you to ensure that the definition of parkland fully protects existing, under construction, and planned parks in the City of San Jose.

Parks are important to the residents of San Jose across the city. Rich or poor, young or old, regardless of ethnicity, religion, gender, or ability: parks are important to us all “ for our physical health, our mental health, and the health of the community.

The City Charter states the public parks of the City shall be inalienable unless otherwise authorized by the affirmative votes of the majority of the electors voting on such a proposition in each case. Further, the Charter states as used herein public park means any and all lands of the City which have been or are dedicated, improved and opened to the public for public park purposes. Additionally, the staff’s memo (https://www.sanjoseca.gov/home/showdocument?id_108319&t_638406648249390275) notes: “Opened to the public for public park purposes means that the public can access the park and enjoy the space. In other words, the City has made the space useable and safe for the public to use. This also includes open space in its natural condition with minimal or no improvements that are intended to be opened to the public.”

I urge the Council to ensure parks are protected in their entirety. Whether improved parks, or unimproved parks that focus public access on contemplative, passive enjoyment of the natural environment and its biological resources. I urge the Council to push for precise and expansive language to provide the maximum protection of our park lands. I also urge the Council to recommend that the City take steps to ensure the protection of planned or under-construction parks. Subject: Synopsis of the Meeting with the Mayor

Last night I attended a small gathering in a home in my neighborhood with the mayor. The setting was good. More should be done. But longer of course. 1 Hour was not enough to get thru the questions about 10 people had. I was asked to attend for small business on what these trailers, encampment and homeless Around us in D10 are doing.

First Matt had a handler who came out and gave us a synopsis on local city government. San Jose has a different system, where the mayor really doesn't make the decisions, the City Manager does. Basically, what he said was the City Manager, Jennifer Maguire, runs the show. She makes the decisions. Matt has no control over the decisions she is making.

I've never met Matt, he seemed pretty young and green. He spouted a lot of useless information probably to kill time. He emphasized more beds coming to D10 and surrounding areas, mainly us, but in the next sentence he said all those beds were already full. So, I'm actually not sure what he is trying to do for us by adding more beds.

But as soon as we could we started asking questions, many good ones. The people around here They get it. They asked a lot of the questions we've all been asking. And they came with statistics. Although he disputed these statistics, and waved around some paperwork saying those numbers were wrong and he had the correct numbers. He gave some confusing answers on where those numbers came from, and the people asking the questions said the city web site. These questions were mainly on the number of sites that are in D10 and why we have the bulk of them. And why it takes so long for action, a question we all have. He never really answered that question, he did say that these sights are distributed evenly. That's not true. We know that.

He did say that it takes a long time to do anything. We can all agree on that!

While these kinds of people embed themselves into society and gain strength and know that nothing will be done, when they disobey laws, and no one does anything, they continue to do so, and it grows. There are no consequences. So, they continue to grow in encampments and trailers and homeless and addicts which he says there is no plan for them. There is nowhere to put them for care.

I came prepared with a list of questions and pictures on small business issues with the homeless, but a lot of my questions were asked. Maybe not answered but asked. I waited patiently because I came to speak about Las Colinas, and surrounding areas, and as it got closer to 7, and the lights were flashing, to tell us it was his time to go I finally had to butt in and say why I was there.

So, I wasn't able to ask my questions, I was able to hand deliver our Open Letter we wrote to him a few years ago, so I know now he actually has it. And I was quickly able to show pictures I brought of what we see on Las Colinas, and Shopping area around us. The people in the room were kind of shocked.

And, as he was leaving, I was able to yell out, what mechanism will come with all these "New Beds" coming to us, by the way, that are already full, to keep them inside, especially at night, so they can't vandal, steal, set fires, basically terrorize our area, and he said he can't make them stay inside.

Defeating any purpose of any help we may need, or any help in the future.

The homeless have more rights than we do.

He did say that the encampment behind Great Oaks church will be dealt with within the next 90 days.

But again, I asked where those people will go, and he said he didn't know. He has no place for them, so they will set up somewhere else.

So, no help there.

He made a comment that there is so much it's hard to get control of it, and I blurted out then put a line in the sand and say that from today forward, no new trailers will be alloyed here and work backwards and start to clean it up.

He says he has no control over how they get here. (Although I heard they were sent from the Fairgrounds area).

The Fairgrounds were mentioned as a solution to house everyone there, which I think is a great idea, but again he has no control on why the Fairgrounds won't give up that area for the greater good.

Someone asked why not buy land basically out in the boonies like maybe Sacramento, and house them all. His answer is he would like to do that, but he is afraid if he ties up 10 Mil dollars, and the land is disputed as being used for homeless, then nothing will get done as it goes through the courts.

And that money won't be available for anything else. And that would anger the constituents.

So basically, he really doesn't make the decisions. And when we all agreed that it was much worse than three years ago, he spouted out that they have made great progress in the last 2 years, and it's much better than it was. That not true.

So, to sum it up, maybe the City Manager needs to go out and meet people. Start copying her on issues. My opinion is that millions, and millions of dollars were spent to create these new sights, and nothing will change. Another great buy of our tax dollars.

He did end with he needs our help in changing government so he can do more. That's likely many moons from now.

Thank you again for your patience and for continuing to raise these concerns. I
 fully understand how disruptive this situation has been for your neighborhood
 and local businesses, and I want to assure you that we are committed to
 addressing it as best we can.

After speaking with Councilmember Batra, we have arranged for officers to be
 sent out to Las Colinas to assess the RV situation. These officers will be
 working on overtime to ensure the issue is addressed promptly. We will be

orange-tagging the vehicles to move and issuing citations for any vehicle code violations. However, I want to be transparent about a significant obstacle we are facing: towing companies are currently refusing to tow oversized vehicles due to the high costs involved in towing and disposing of them. This means we are unable to remove the RVs as quickly as we would like.

Additionally, the recent influx of RVs to Las Colinas is likely due to our recent activity asking RVs to move off Realm Drive, which is in the same general area.

We are working closely with the City Manager's Office and the towing vendors to find a resolution, but in the meantime, we are launching an Oversized Vehicle Regulation Pilot Program. This program will establish temporary tow-away zones in the areas most affected by the presence of oversized and lived-in vehicles, allowing for trash cleanup and street sweeping.

I also want to acknowledge the comparisons made to actions taken in other Council districts. It is important to recognize that each area of San Jose is unique, with different challenges and dynamics. What may have worked well in one district may not be as effective in another due to variations in population density, neighborhood layout, and the specific needs of the residents and businesses in the area. We are committed to finding solutions tailored to the unique circumstances of Las Colinas and surrounding neighborhoods. Our approach is designed to meet the specific demands of your community, and we appreciate your understanding as we work through these complex issues.

I know this is not the immediate solution you were hoping for, but I want to emphasize that this issue is a priority, and we will continue enforcing what we can while working toward a longer-term resolution. Your engagement and patience are greatly appreciated.

I personally spoke to one intern in the District 8 office and was told that you all were working diligently on taking care of that situation and it is now all cleared. I will say I am the one who gave out the email addresses to the homeowner's at the Terrace Hills HOA because their vehicles and homes were being broken in to due the people from the RVs jumping the fences or they were jumping the fences to go in to the HOA swimming pool. I am in that neighborhood frequently and it is now staying clear from all of the vehicles parking where they were. I have spoken to colleagues that live over there and they have informed me that there has been two occasions when the trailers or vehicles have returned and someone shows up and they move immediately. The company I work for manages this HOA and also one off of Santa Teresa Blvd where the RV's are also parked.










































They are being confronted by homeowners, and soon this will be a big problem. Someone will be hurt. These trailers have been ticketed elsewhere, you can find that out, send them back to where they came from. If it is the fairgrounds, then send them back there. Someone there is telling them to come here.

Take control before homeowners do.

Why is the city always behind what is happening. You all get paid to do this job, now do it.

There certainly is a lot of you in the mayors office, I get notes from about 20 different city people.

That's your job.

Doing nothing is not an option now. This whole area in South San Jose is filthy dirty, Homeless on the streets, stealing, begging, encampments, trailers, drug addicts.

And more are coming weekly. This is not how we live. We live in a civilized city, and you all have ruined this area from not doing your jobs.

Don't put them here, we have enough to deal with. We are unable to handle what is here now.

Families have to explain this to their kids when they walk to school, when they see buckets on their curbs for human waste, weapons, gangs, fights, stealing.

This is not in your neighborhood. You wouldn't allow it.
