2023 General Plan Amendment Cycle (Cycle 2) File No. GPT23-003

WHEREAS, the City Council is authorized by Title 18 of the San José Municipal Code and state law to adopt and, from time to time, amend the General Plan governing the physical development of the City of San José; and

WHEREAS, on November 1, 2011, the City Council adopted the General Plan entitled, "Envision San José 2040 General Plan, San José, California" by Resolution No. 76042, which General Plan has been amended from time to time (hereinafter the "General Plan"); and

WHEREAS, in accordance with Title 18 of the San José Municipal Code, all General Plan and Specific Plan amendment proposals are referred to the Planning Commission of the City of San José for review and recommendation prior to City Council consideration of the amendments; and

WHEREAS, on December 6, 2022, the City Council adopted amendments to Council Policy 5-1 to streamline environmental review under Vehicle Miles Traveled (VMT) for affordable housing and market housing projects, and to provide a process for City Council to consider adopting a Statement of Overriding Considerations under California Environmental Quality Act for housing projects with Significant and Unavoidable VMT Impacts; and

WHEREAS, the City proposes to amend General Transportation Policy TR-1.4 to allow

for implementation of the updated City Council Policy 5-1 related to Statement of

Overriding Considerations, as set forth in Section 1.D and Section D.2.C of Appendix B

of City Council Policy 5-1; and

WHEREAS, on May 24, 2023, the Planning Commission held a hybrid public hearing to

consider the proposed text amendments to the General Plan to update Transportation

Policy TR-1.4 (File No. GPT23-003), as specified in Exhibit A hereto ("General Plan

Amendment"), at which hearing interested persons were given the opportunity to appear

in person or virtually and provide public comments with respect to said proposed

amendment; and

WHEREAS, at the conclusion of the public hearing, the Planning Commission transmitted

its recommendations to the City Council on the proposed General Plan Amendment; and

WHEREAS, on June 20, 2023, the Council held a duly noticed public hearing; and

WHEREAS, a copy of the proposed General Plan Amendment is on file with the City of

San José Director of Planning, Building and Code Enforcement and available online

digitally at sipermits.org, with copies submitted to the City Council for its consideration;

and

WHEREAS, pursuant to Title 18 of the San José Municipal Code, public notice was given

that on June 20, 2023, at 1:30 p.m., the Council would hold a public hearing where

interested persons could appear, be heard, and present their views with respect to the

proposed General Plan Amendment (Exhibit A); and

File No. GPT23-003. The Envision San Jose 2040 General Plan is hereby amended as

follows:

1. Chapter 6, "Transportation Policies" section, pages 37-38, Policy TR-1.4 is hereby

amended to read as follows:

TR-1.4 Through the entitlement process for new development, projects shall be

required to fund or construct needed transportation improvements for all

transportation modes giving first consideration to improvement of bicycling,

walking and transit facilities and services that encourage reduced vehicle travel

demand.

• Development proposals shall be reviewed for their impacts on all

transportation modes through the study of Vehicle Miles Traveled (VMT),

Envision San José 2040 General Plan policies, and other measures

enumerated in the City Council Transportation Analysis Policy and its

Local Transportation Analysis. Projects shall fund or construct

proportional fair share mitigations and improvements to address their

impacts on the transportation systems.

The City Council may consider adoption of a statement of overriding

considerations, as part of an EIR, for projects unable to mitigate their VMT

impacts to a less than significant level. At the discretion of the City Council,

based on CEQA Guidelines Section 15021, projects that include

overriding benefits, in accordance with Public Resources Code Section

21081 and are consistent with the General Plan and the Transportation

Analysis Policy 5-1 may be considered for approval. The City Council will

only consider a statement of overriding considerations for (i) market-rate

housing located within General Plan Urban Villages market-rate or mixed-

income housing consistent with the General Plan Land Use Designation

effective on November 29, 2022 or future City-initiated General Plan

amendments; (ii) market-rate or mixed-income housing that requires a

privately initiated General Plan amendment that is on land currently

designated with a Private Recreation and Open Space land use

designation; (ii)(iii) commercial projects; er(iv) industrial projects; and

(iii)(v) 100% deed-restricted affordable housing as defined in General Plan

Policy IP-5.12. Such projects shall fund or construct multimodal

improvements, which may include improvements to transit, bicycle, or

pedestrian facilities, consistent with the City Council Transportation

Analysis Policy 5-1.

Area Development Policy. An "area development policy" may be adopted

by the City Council to establish special transportation standards that

identifies development impacts and mitigation measures for a specific

geographic area. These policies may take other names or forms to

accomplish the same purpose.
