**A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE AUTHORIZING “FREE USE” FOR EVENTS AND ACTIVITIES HELD AT CITY HALL FOR THE 2023 TRANS DAY OF VISIBILITY ON SATURDAY, APRIL 29, 2023 CO-HOSTED BY THE COUNCIL DISTRICT 6 OFFICE, THE COUNCIL DISTRICT 9 OFFICE, AND BILLY DEFRANK LGBTQ+ COMMUNITY CENTER**

**WHEREAS**, in June 2016, the Council of the City of San José (“City”) adopted Schedule of Fees Resolution No. 77829 for the fees and charges for City Hall Facility Use; and

**WHEREAS**, Resolution No. 77829 authorizes the City Council, Redevelopment Agency Board, and City departments to have “Free Use” of the facilities for those events that 1) qualify as official City business; 2) are free and open to the public; 3) occur on a Sunday through Friday; and 4) are booked 30 days in advance; and

**WHEREAS**, “Free Use” does not apply to Saturday events, and, therefore, Council approval is necessary; and

**WHEREAS**, the Council District 6 Office and the Council District 9 Office have requested that “Free Use” be authorized for events and activities for the 2023 Trans Day of Visibility, which is expected to significantly benefit the City if scheduled on a Saturday as it would accommodate the schedules of community members who work full-time jobs during the week and increase the number of participants; and

**WHEREAS**, the 2023 Trans Day of Visibility is co-hosted by the Council District 6 Office, the Council District 9 Office and the Billy DeFrank LGBTQ+ Community Center and directly aligns with top City priorities and policies by providing access to information for a diverse population that includes transgender/nonbinary/intersex people; and

**WHEREAS**, the City finds that the 2023 Trans Day of Visibility qualifies as official City business because it supports the City’s mission to provide quality public services, facilities and opportunities that create, sustain, and enhance a safe, livable, and vibrant community for its diverse residents, businesses, and visitors; and

**WHEREAS**, the City desires to allow for the free use of the City Hall Rotunda, Wing Committee rooms, and parking in the City Hall Garage and 4th Street Garage for the 2023 Trans Day of Visibility on Saturday, April 29, 2023;

**NOW, THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

The City Council hereby authorizes “Free Use” of the City Hall Rotunda, Wing Committee rooms, and parking in the City Hall Garage and 4th Street Garage for events and activities for the 2023 Trans Day of Visibility on Saturday, April 29, 2023 co-hosted by the City of San José Council District 6 Office, Council District 9 Office and the Billy DeFrank LGBTQ+ Community Center.
