My name is Lisa Matichak and I am a Councilmember in the City of Mountain View. I am hoping to attend your Council meeting today on behalf of the City of Mountain View. However, we also have a Council meeting today so in case I can't make it I am sending input on item 6.1, Formation of the Ad Hoc Advisory Committee on South Flow Aircraft Arrivals at San Jose Airport.

The City of Mountain View is severely impacted when the south flow is used at San Jose Airport. Last year the south flow was used more than in previous years and we definitely heard from our residents who asked the Council for help. While some aircraft noise is unavoidable in the Bay Area, the south flow creates a constant, loud stream of aircraft right over Mountain View. For many, this is having a negative impact on their quality of life, interrupting sleep, impacting work, and in general is an unwelcome intrusion.

We are very supportive of forming an Ad Hoc Advisory Committee on South Flow Arrivals to address noise. There are many potential solutions that can be explored. We are anxious to start working with others on this issue that is having such a negative impact on the quality of life not only in Mountain View but also in other cities.
