• Adjournment Recognition

Councilmember Bien Doan presented the adjournment for this meeting at 1:56 p.m. in memory of Nguyên Trung Chinh (aka Chinh Nguyên) who passed away on April 7, 2025. As the founder of the nonprofit Văn Thơ Lạc Việt in 2015, he created a meaningful space for Vietnamese writers, poets, and artists to share their voices and connect with the broader community. His work enriched San José's cultural landscape and ensured that the experiences, values, and contributions of the Vietnamese community continue to be honored and preserved for future generations. Mr. Chinh Nguyên helped make San José a stronger, more inclusive city—one where the stories of all communities are celebrated.
