THREE E'S APPROACH TO BLIGHT

The "Three Es" model—Education, Eradication, and Enforcement—continues to serve as a holistic and most effective framework for addressing the complex issue of illegal dumping.



2024-2025 Highlights

- **BSJ removed 24.4 million pounds of trash**
 - **14.3 million pounds removed as part of blight reduction efforts**
- **Eradicated 2.5 million square feet of graffiti**
 - **14.73% decrease from the previous year**
- **Launched the Blight Enforcement Working Group**

EDUCATION STRATEGY

ENVIRONMENTAL STEWARDSHIP PROGRAM

The Environmental Stewardship Program was piloted at Franklin Elementary, Washington Elementary, and Katherine Smith Elementary schools this fiscal year.

- 974 youth were engaged
- 1,139 hours of service provided



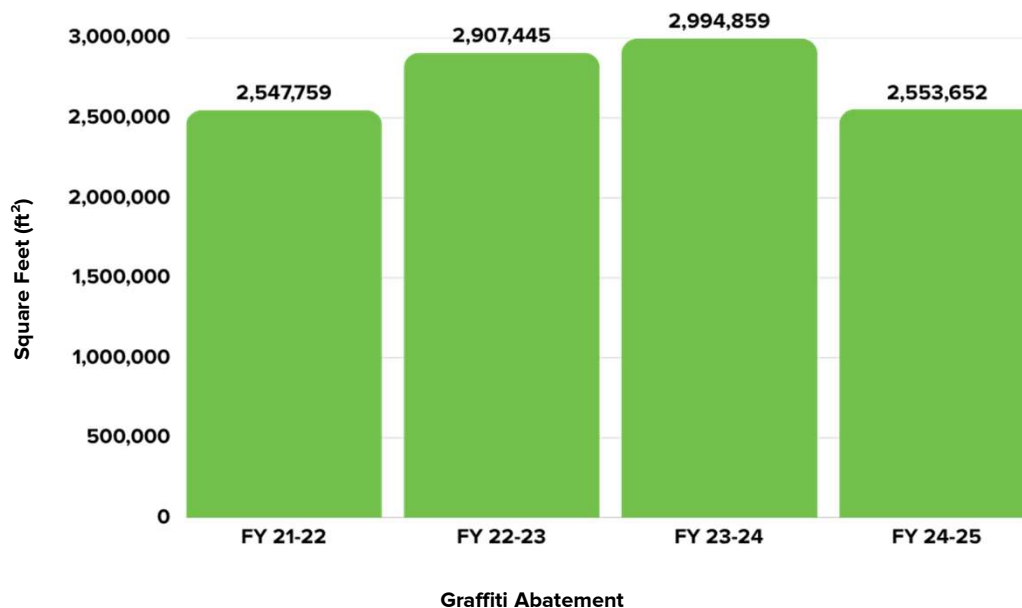
EDUCATION, MARKETING & OUTREACH



- Multilingual advertising campaign to raise awareness and promote community engagement
 - 25 transit shelter ads
 - 50 bus back ads
 - 12-week ad run
 - Eastridge Mall Blight Reduction Campaign - August 2024 – current

ERADICATION EFFORTS - GRAFFITI REMOVAL PROGRAM

Fiscal Year Comparison of Graffiti Removal Program Performance



- 29,200 work orders completed
- **2,553,652 sq ft of graffiti removed**
 - **14.73 % decrease**
- 442,125 sq ft of gang-related, hate, or offensive graffiti removed
 - 23.4% decrease from 2023-2024
- 8,570 incidents on private property responded to
- 29.35% of graffiti involved private property, compared to 6% in 2023-2024

ERADICATION EFFORTS – ILLEGAL DUMPING

- 28,303 work orders completed
- 10,576,000 lbs. of trash and debris collected
- 3.2 average service days maintained
- 80% response time goal met

Comparison of Illegal Dumping Program Performance



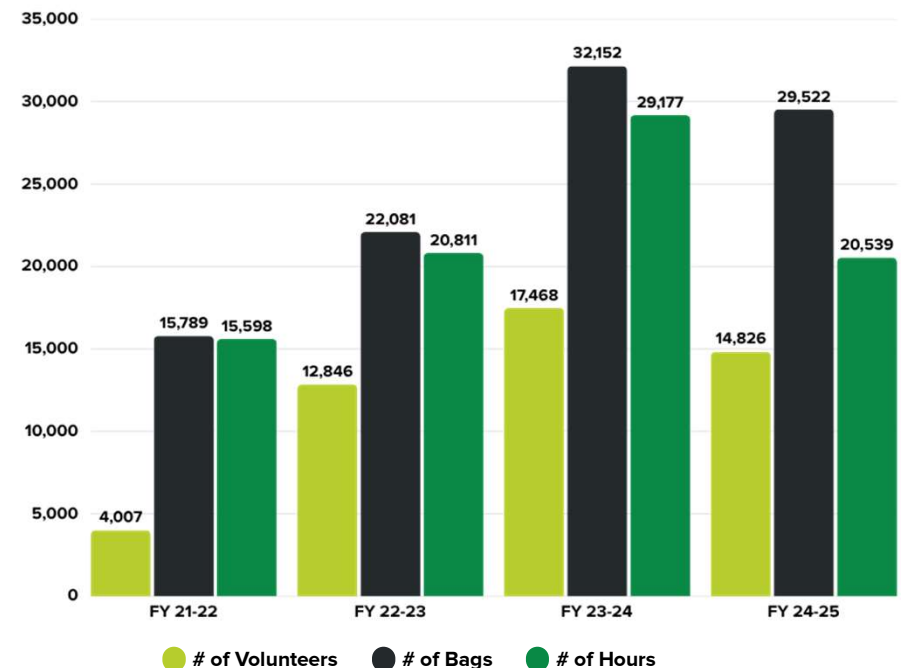
ERADICATION EFFORTS - NEIGHBORHOOD LITTER PROGRAM

- 14,826 residents volunteered
- 20,539 volunteer hours
- 718,865 pounds of litter and debris removed
- \$714,551 in volunteer contribution

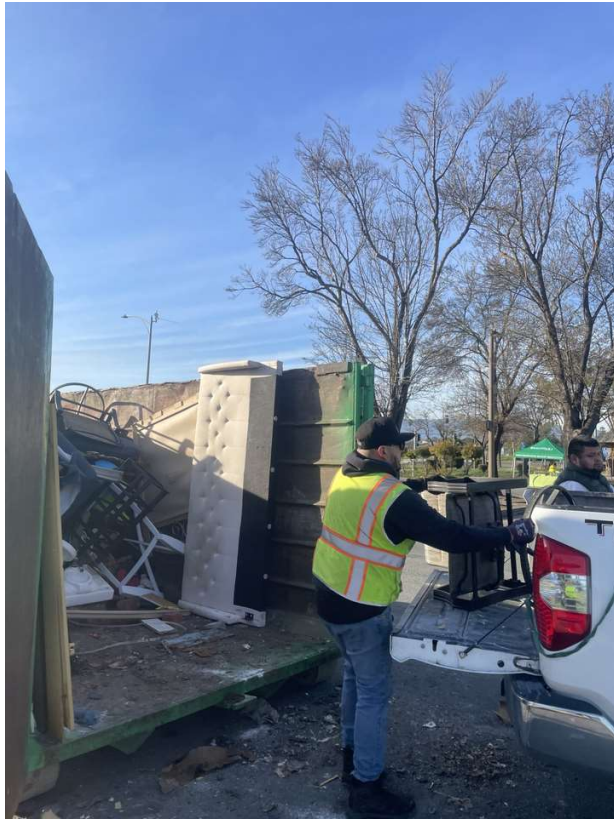
Challenge: Schools now require MOU's prior to litter education engagement with students, this impacted the number of presentations and volunteers.

Presentations declined from 74 to 47.

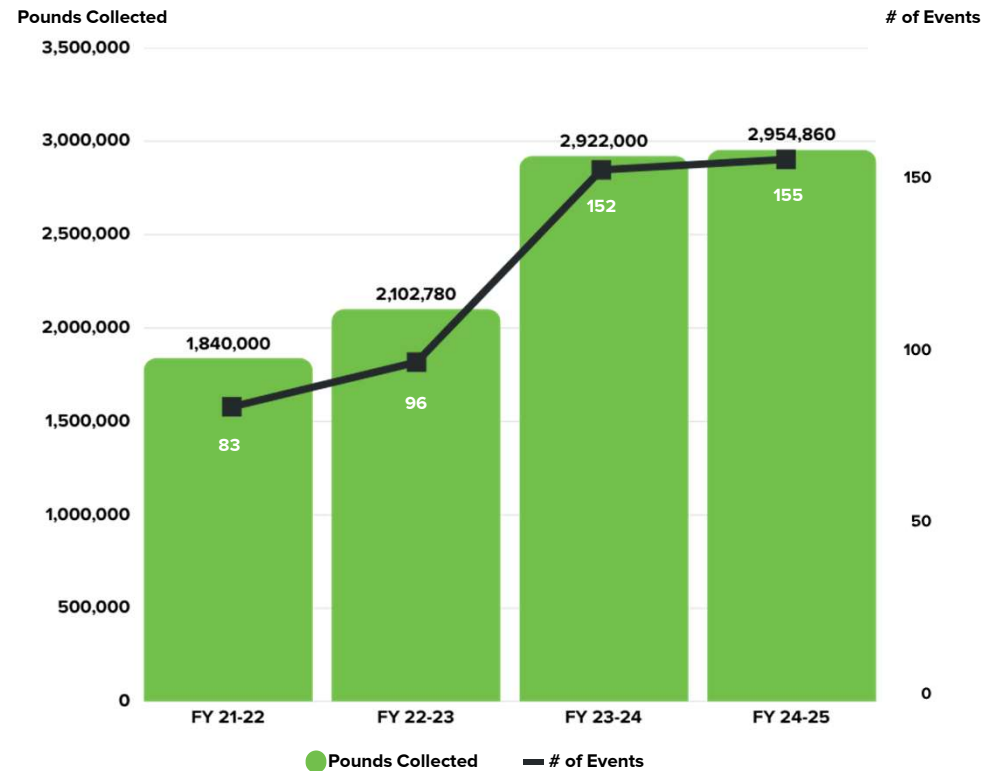
**Fiscal Year Comparison

DETERRENTS AND ENFORCEMENT ACTIONS

- Launched a Blight Enforcement Working Group
 - Funds appropriated in 2025-2026 to support efforts
- Illegal Dumping
 - 12 cameras to monitor illegal dumping in high-volume illegal dumping hotspots
 - 32% decrease in areas where cameras are installed
- Graffiti
 - SJPd assisting with enforcement
 - 3 taggers arrested
- Clean Gateways Project
 - 9 gateways + 2 corridors being maintained 3x week
 - Restoration phase with water wise vegetation being added
