### b. 69 E SAN FERNANDO ST (467-22-056)– ADMINISTRATIVE REMEDY

(Wayne Cirone, Code Enforcement Inspector/Eagles Hills Property LLC, GTL Investments LLC, Jose Anthonio Castillo, Property Owners)

The Director of Planning, Building and Code Enforcement requests a hearing on a proposed order to require the Property Owners to take the corrective actions including Public Works permits to install a covered walk way that would re-open the public right of way to pedestrian traffic; install continuous exterior lighting from dusk to dawn; post responsible party information signage; secure and maintain all openings and fencing to prevent unauthorized entry; remove graffiti; cover with sufficient paint all unfinished boarded openings; and ensure compliance with San Jose Municipal Code Section 17.38.200 by obtaining and maintaining a valid, unexpired building permit with inspections occurring at least every six months.

Recommendation: Issue an administrative order as set forth in the Staff Report dated July 24, 2024.
