## **RECOMMENDATION**

## **SUMMARY AND OUTCOME**

This action will allow the City of San José to have a voting representative at the General Assembly at the annual meeting of the League of California Cities (League).<sup>1</sup>

## **BACKGROUND**

The League is a member organization that advocates for federal and state policies that support California towns and cities. Each year, the League convenes a General Assembly to approve resolutions for the organization. Resolutions are policy statements that guide the League's legislative positions and actions. To expedite the conduct of business at the General Assembly meeting, each California member town or city's legislative body designates a voting representative for the annual meeting.
