BACKGROUND

The Fall Festival will be held on September 28, 2017 at the Taylor Street Night Market and sponsored by Councilmember Raul Peralez. This special event will provide residents with a fun filled night of family activities, food, and live music to enjoy. The event is free and open to the public.

ANALYSIS
