

# MINUTES OF THE JOINT MEETING OF THE RULES AND OPEN GOVERNMENT COMMITTEE AND COMMITTEE OF THE WHOLE

## C. Rules Committee Reviews, Recommendations and Approvals

## 1. Modifying SJMC 12.08.030(a) - Gift Limits. (Cohen and Foley)

Amend San José Municipal Code 12.08.030(a) to increase the gift limit from \$50 to \$200 from a single source in a calendar year.

Public Comment: None provided.

Action: Upon motion by Councilmember Domingo Candelas, seconded by Councilmember Rosemary Kamei, and carried unanimously, San José Municipal Code section 12.08.030(a) was approved to be amended to increase the gift limit from \$50 to \$200 from a single source in a calendar year. (5-0-0)

#### 2. Economic Revitalization Fund for East San José. (Ortiz)

Direct staff to return, as part of the FY 2026-2027 budget priority setting study session, with a conceptual framework for establishing an Economic Revitalization Fund dedicated to improving the public safety, cleanliness, economic vitality, and public infrastructure of East San José. The framework can then be considered during the 2026-2027 budget cycle, where city funds can be leveraged alongside state and federal grants and philanthropic dollars.

The framework should include:

- · An allocation of \$30 million to be used on projects to revitalize the East Side.
- · A timeline for fund development and initial allocations.
- · Identification of eligible uses and priority investment areas.
- · Strategies for leveraging external funding sources.
- · Mechanisms for ensuring transparency, accountability, and community engagement.
- · Robust public outreach with the East San José Community to determine spending priorities.

Councilmember Peter Ortiz introduced the item, bringing forward the recommendation as outlined in his memorandum, dated August 21, 2025.

Public Comment: Jose Abastida, Danny Garza, and Gabriel Manrique offered public comment.

Vice Mayor Pam Foley requested that staff advise on the budget analysis process.

Lee Wilcox, Assistant City Manager, City Manager's Office, recommended referring Councilmember Peter Ortiz's memorandum to the 2026-2027 March Budget Message.

<u>Action</u>: Upon motion by Vice Mayor Pam Foley, seconded by Councilmember Domingo Candelas, and carried unanimously, the Economic Revitalization Fund for East San José was referred to the budget process, as part of the 2026-2027 March Budget Message. (5-0-0)

# D. Open Forum

1. James Campbell offered public comment regarding public safety, in reference to pedestrian-related accidents and challenges related to visibility and crosswalks.
