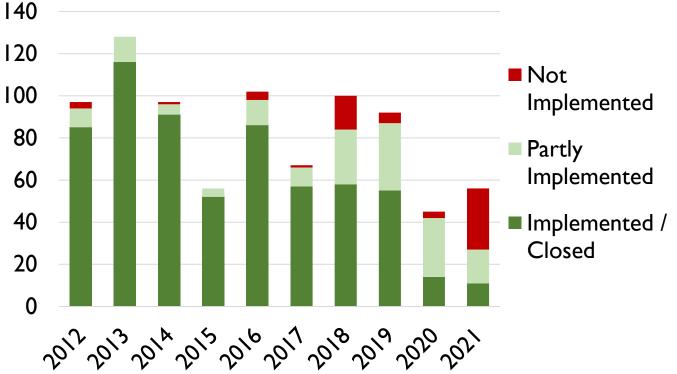
#### Summary of Results:

- > 261 recommendations
- > 34 new recommendations made since last update
- > 43 implemented or closed since last update
- > 156 partly implemented, 62 not implemented



Percent of Recommendations

- ✓ 74% of recommendations made over last 10 years
- ✓ 54% of recommendations made over last 5 years





#### Departments Implemented 43 Recommendations Since the Last Update

Highlights include:

- The Police Department made additional progress implementing recommendations from our audit of the Police Secondary Unit
- Office of Equality Assurance developed standard procedures for wage compliance reviews
- PRNS implemented multiple recommendations from our audit of the Neighborhood Center Partner Program (formerly reuse)
- The Administration created a map of neighborhood and business associations



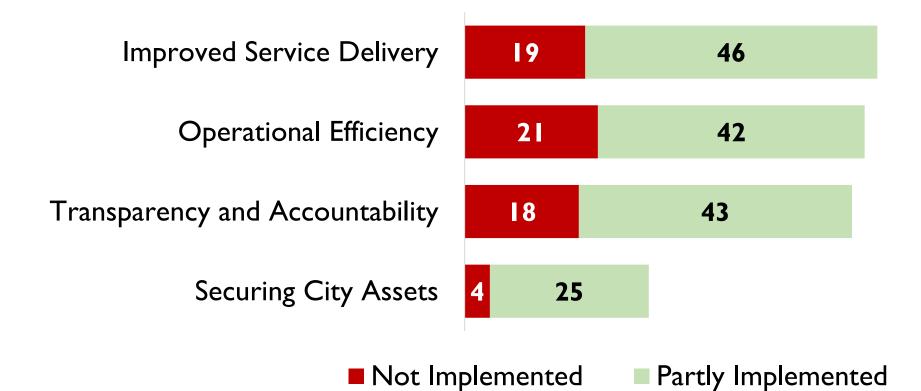
#### Departments Implemented 43 Recommendations Since the Last Update

Highlights include:

- Public Works updated the City's Vehicle Replacement Policy
- PBCE has developed new procedures around supervisory review of open and closed code enforcement cases
- The Administration created an electronic registration form for Municipal Water customers qualifying for Low-Income or Medically Vulnerable service options

- Massage Program roles and responsibilities (Audit of Code Enforcement Management Controls, 2021)

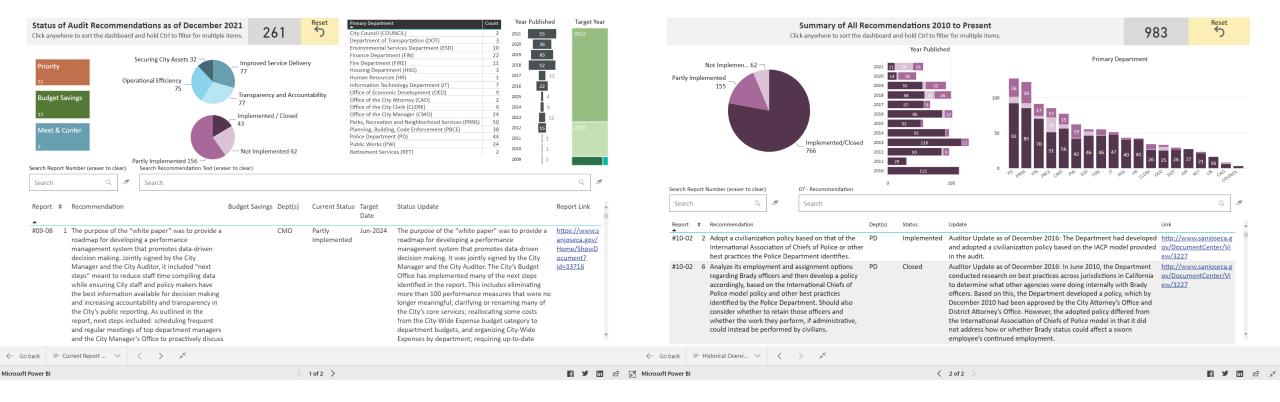
