C.3 New and Redevelopment & Green Stormwater Infrastructure (GSI)

- Accomplishments To Date:
 - Updated Title 20, Council Policies
 - More stringent GSI requirements became effective July 1, 2023:
 - Approximately 56% of private development projects submitted to the City after July 1, 2023 may be required to implement GSI
 - River Oaks Regional Stormwater Capture GSI project estimated to complete by Summer 2024
 - C.3 Amendment effective November 1, 2023
 - Temporary Emergency Housing Projects exempt from GSI
 - Updated Affordable Housing formula for treatment credit

- Evaluate Alternative Compliance needs
- Determine an appropriate in-lieu fee payment system







C.10 Trash Load Reduction and C.17 Discharges Associated with Unsheltered Homeless Populations

- Accomplishments To Date:
 - Achieved 90% Trash Load Reduction by June 30, 2023 due date
 - Long-Term Trash Plan submitted September 30, 2023
 - Direct Discharge Program resubmitted plan twice on October 2, 2023 (awaiting approval)
 - Regional C.17 Best Practices Report – submitted September 30, 2023

- Next Steps:
 - Long Term Trash Plan Need funding to implement structural control by June 30, 2025 to be 100% compliant
 - Full Trash Capture
 - Private Lands
 - **Direct Discharge**
 - Additional funding for services and housing needs for unsheltered populations living in waterways
 - Minimize sanitary discharges into storm drains from lived-in vehicles









C.12 Polychlorinated Biphenyls (PCBs)



- Submitted Regional Control Measure Plan – March 2023
- 8 Source Properties identified
- Moderate areas identified
- Updated Municipal Codes (Title 15) and permit process for PCBs-containing materials from building demolitions

- Respond to Water Board comments on the Regional Control Measure Plan
- Determine best approach Refer to Water Board or City to directly enforce on identified 8 Source Properties
- Additional Monitoring,
 Investigation, and Enforcement of
 22 properties in Moderate areas
- Implement enhanced O&M in Old Industrial Areas









C.15.b.iii. Emergency Discharges of Firefighting Water and Foam

- Accomplishments To Date:
 - Fire and ESD participated in Biannual Regional Working Group Meetings
 - Reviewed and began updating existing Emergency Firefighting Runoff Management policies

- Develop regional approach to large industrial site
- Finalize runoff procedural manuals, notification procedures, and policies
- Submit Regional BMP Report to the Water Board – September 30, 2025









C.20 Cost Reporting and C.21 Asset Management



- Participated in development of Bay Area regional cost reporting framework
- Submitted Bay Area regional cost reporting framework -June 30, 2023
- Provided feedback for State Water Board draft cost reporting policy

- Initiate cost framework into City budget/fiscal tracking
- Submit annual cost analysis of stormwater programs starting with FY 24-25
- Seek funding to initiate asset management plan due by June 30, 2025 and implementation starting July 1, 2025





Critical Milestones and Needs

- Awaiting Water Board approval for the Direct Discharge Plan
- Prepare and submit remaining required deliverables
 - Update PCBs Control Measures Plan
 - Assess and implement Citywide Cost Reporting requirements
 - Evaluate approach for Asset Management requirements
- Seek comprehensive funding to implement for required compliance actions
