City Manager, Jennifer Maguire offered the verbal report and announced that the City recently received several large grants totaling in over 18 million dollars. The grants will provide abundant investments and enhancements to the Cities delivery to critical City programs and services to help make San José safer, cleaner, and greener. The California Board of State Corrections awarded the San José Police Department an 8.5 million dollar competitive grant to combat organized retail crime. The U.S Department of Agriculture Forest Service awarded the City a 6.6 million dollar grant to help the City grow tree canopies along streets in underserved neighborhoods in San José. The Cities airport received a grant for 3.3 million dollars to aid in purchasing zero emission vehicles.
