Quaint and memorable aspects of a city are not built from scratch but evolve in an orderly manner from the n of existing with a contextual reference and appreciation of surroundings. No meaningful places were created in the 1960s and 70s slash-and-burn inner city redevelopment; many cities lost their historical character through development in this manner. My belief is that appropriate development looks at preservation as the first element of design: It has to be accurately read and acknowledged to form the template and the basis for progress. The Historic Landmarks Commission is an important forum to air the concerns and act as as an element aiding the planning process in the city. In an era of green architecture and reuse, the least intrusive building is the existing building.
