SUBJECT: REPORT ON REQUEST FOR BIDS FOR CITYWIDE PURCHASE ORDERS FOR DESKTOPS, LAPTOPS, TABLETS, AND MONITORS

RECOMMENDATION

Adopt a resolution authorizing the City Manager to:

- a. Execute purchase orders with ComputerLand of Silicon Valley (San José, CA) for desktops and Chromebook laptops; Saitech, Inc. (Fremont, CA) for android tablets; SHI International Corp. (Somerset, NJ) for desktops, Apple iOS tablets, and Apple MacBook Pro laptops; and Granite Data Solutions (Sacramento, CA) for monitors for a combined maximum not-to-exceed compensation of \$1,345,000 for the initial one-year term ending September 30, 2021, subject to the appropriation of funds.
- b. Amend purchase orders with Saitech, Inc. for 2-in-1 laptops to increase by up to \$217,000 for a maximum compensation of \$347,000, and SHI International Corp. for standard, large screen, ruggedized laptops to increase by up to \$750,000, for a maximum compensation of \$1,600,000 for the initial one-year term, subject to the appropriation of funds.
- c. Approve a contingency of \$800,000 for all purchase orders as required to meet unanticipated increases in demand for computers, tablets, and monitors during the initial term, subject to the appropriation of funds.
- d. Execute purchase orders for these products for up to four additional one-year options through September 30, 2025, subject to the appropriation of funds.

OUTCOME

Provide City departments with a quick and efficient process to purchase pre-approved desktop computers, laptop computers, tablet computing devices, and monitors to support City work.

BACKGROUND

City staffs require procurement vehicles to purchase a variety of desktops, laptops, tablets, and monitors, based on standards set by the Information Technology Department to maximize Citywide interoperability. Purchases are made on an as needed basis throughout the year. To facilitate this, Finance-Purchasing and the Information Technology Department collaborate to competitively bid these items periodically to ensure the City optimizes its value through volume pricing discounts, providing access to products with current and highly reliable technology features, and accelerating ordering processes for departments.

Citywide purchase orders are issued to allow City staff to purchase from a list of prequalified vendor products that reflect pricing established for the City through the competitive bidding process. Executing purchase orders for a variety of desktops, laptops, tablets, and monitors allows staff to order computing devices within prescribed requirements as their operational needs require and budgets permit.

Due to the need to expedite purchases to enable remote work as necessitated by COVID-19, and to spend available federal funds in a timely manner, some purchase orders have been issued under the City Manager's contract authority. The recommendation in this memorandum also includes a provision for increasing those purchase orders.

ANALYSIS

Request for Bids #1: Desktops, Laptops, and Tablets

(City-funded, included Local Business Enterprise (LBE)/Small Business Enterprise (SBE) Preference)

In June 2020, the Finance Department released a Request for Bids (RFB #1) for Citywide Desktops, Laptops, and Tablets through the City's e-procurement system, Biddingo. A total of forty (40) vendors viewed the RFB. Seven (7) vendors responded prior to the submittal deadline, and the bid results are as follows, with the bold, yellow highlighted cells designating the awarded vendors:

Since RFB #1 did not yield a successful outcome for Laptops and MacBooks, the Finance Department released two new solicitations, RFB #2 and RFB #3, in September 2020 for these items.

A total of twenty-six (26) vendors viewed RFB #2. Responses were received from four (4) vendors prior to the submittal deadline, and the results are as follows:

RFB #4: Monitors

(City-funded, included LBE/SBE Preference)

In September 2020, Finance released RFB #4 for Monitors. A total of twenty-six (26) vendors viewed the RFB. Six (6) vendors submitted bids prior to the submittal deadline, and the bid results were as follows:

Local and Small Business Enterprise Preference: In accordance with San José Municipal Code Section 4.12.320.B, vendors who requested and received the local business preference were given a two and one-half (2.5) percent credit and, of those, a two and one-half (2.5) percent credit if also a small business. All RFBs except RFB #3 included the City's Local and Small Business Preference (LBE/SBE) and are to be used for purchases funded with City funds.

RFB #3 excluded the LBE/SBE preference since purchases are to be funded with federal funds, e.g., FEMA (Federal Emergency Management Agency) and CRF (Coronavirus Relief Fund). Those require additional solicitation and contracting provisions and prohibit the use of geographic preferences. For RFB #s 1, 2, and 4, one (1) bidder, ComputerLand of Silicon Valley, requested and received the local and small business preferences for their local office located within Santa Clara County. The local and small business preference was a factor in the final award for Mid Tower Workstation Desktops, Small Form Factor Workstation Desktops, and Chromebook Laptops in RFB #1.

Review Process: For each solicitation, the lowest-priced product for each category was reviewed by the Information Technology Department to verify that it met or exceeded the City's published specifications. If it did, the vendor was awarded the bid for that category. If it did not, the bid was identified as non-responsive, and staff went to the next lowest priced vendor in that category. This process was repeated until staff identified the lowest-priced product in each category that met or exceeded the City's requirements.

Protest: The City's RFB process included a ten-day protest period that began when the City issued the Notice of Intended Award for each solicitation. No protests were received.

Cost Plus Markup: All RFBs allowed for the purchase of upgrades, accessories, or next generation equivalent models based on a specified percent markup over the vendor's cost. The City may, at its sole discretion, request documentation from an awarded vendor that demonstrates their actual cost at any time during the contract term to verify that the City's pricing is in accordance with the solicitation. This allows the City to benefit from industry improvements to technology hardware.

Award Recommendation: Staff recommends awards to the vendors identified below as the lowest-priced responsive and responsible bidders per the minimum requirements set forth in the RFB and pursuant to the formal bidding process of the San José Municipal Code, Section 4.12.310B:
