A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE (A) APPROVING THE AWARD OF DIGITAL INCLUSION **GRANTS:** AUTHORIZING (B) \$<del>787,550</del>182,000 **PAYMENT FROM** THE **DIGITAL** CALIFORNIA INCLUSION **FUND** TO **EMERGING** TECHNOLOGY FUND (CETF) AND USE OF \$387,750 IN DONATED FUNDS IN THE CITY FUND MANAGED BY CETF TO DISTRIBUTE THE GRANT AWARDS TO THE GRANTEES PURSUANT TO THE CITY'S AGREEMENT WITH CETF; AND (C) AUTHORIZING THE OR DESIGNEE TO NEGOTIATE MANAGER AND EXECUTE Α SECOND AMENDMENT TO AGREEMENT WITH CETF TO ALLOW A ONE-TIME PAYMENT OF \$20,000 IN JULY 2022 TO CETF FOR THE SEPARATE ADMINISTRATION OF DIGITAL INCLUSION GRANTS TO SCHOOLS THAT SUPPORTED THE CITY'S COVID-19 EMERGENCY RESPONSE AND A ONE-TIME PAYMENT OF UP TO \$72,500 IN JUNE 2023 TO SUPPORT THE CITY'S DIGITAL INCLUSION PROGRAM ASSESSMENT AND CHANGE MANAGEMENT

WHEREAS, on November 13, 2017, the Council of the City of San José ("City") approved the City's Digital Inclusion and Broadband Strategy, which established an intentional focus on digital inclusion and equity, supported by a sustainable funding stream, and with a path to close the digital divide; and

WHEREAS, in 2018, the City Council approved public-private partnership agreements for small cell deployments on City-owned streetlights and directed the City Manager to allocate small cell usage fee revenue to create a "Digital Inclusion Fund" ("DIF") within the General Fund to support efforts to close the digital divide in San José; and

WHEREAS, on February 12, 2019, the City Council authorized the City Manager to negotiate and execute an agreement with California Emerging Technology Fund

("CETF") for the purposes of disbursement of the City's grant awards and acting in the capacity of fiscal agent for the DIF grant program; and

WHEREAS, on February 25, 2020, the City Council approved issuance of \$1,000,000 to CETF to fund the first round of DIF grants to 21 community-based organizations ("CBOs") and two City departments serving San José residents; and

WHEREAS, on May 19, 2020, the City Council authorized the City Manager to negotiate and execute an amendment to the City's agreement with CETF to allow distribution of funds donated to the DIF to relieve the connectivity impacts of COVID-19; and

WHEREAS, CETF executed and managed 11 grant agreements with the Santa Clara County Office of Education to distribute donations made specifically to assist with digital connectivity during the pandemic to seven San José school districts to provide computing devices to students; and

WHEREAS, on June 8, 2021, the City Council approved the conditional award of up to \$500,000 in additional Round 2 grant funding to existing grantees; and

WHEREAS, the application period for the Round 3 grant cycle opened on November 9. 2021 and closed on February 1, 2022, and the City desires to disburse Round 3 grant funding of \$787,550752,500 from the DIF to 15 CBOs serving San José; and

WHEREAS, the City also desires to amend the agreement with CETF to permit a onetime payment of \$20,000 from the DIF to CETF for COVID-19 specific grant administration performed in Fiscal Year 2020-2021, and allow for a one-time payment in Fiscal Year 2022-2023 of up to \$72,500 for CETF to support the City's Digital
