

Dear Mayor Liccardo and City Council,

On the news this morning, I heard a segment in which Councilmember Peralez raised concerns about very low income tenants not having access to legal representation to fight evictions and so he was proposing the City of San Jose give free legal representation to tenants who claim they cannot pay rent. Since low income tenants have access to 100% rental assistance through the State's Rental Assistance Program, they should not need free legal representation for evictions since low income households impacted by Covid-19 have the means and opportunity to pay all rent owed. The statutory amendments created by AB 832 protect them from eviction so long as they are doing their part to obtain rental assistance and incentive landlords to assist them in any way they can. In fact, if a landlord does not apply for rental assistance, they cannot proceed with an eviction. If additional financial assistance from the government is needed to get the rent relief applications and payments expedited, then that is what the City should be funding not lawyers.
