AMENDMENT NO. 1 TO COOPERATIVE AGREEMENT FOR LOCAL IMPROVEMENTS

This Amendment No. 1 ("First Amendment") to	Agreement 04-2611 ('Agreement"), entered
into, and effective on,	2017, is between the State of
California, acting through its Department of Tra	ansportation, referred to as "CALTRANS", and

CITY OF SAN JOSE, a municipal corporation of the State of California, referred to herein as "CITY."

RECITALS

- 1. CALTRANS and CITY, collectively referred to as "PARTNERS", entered into Agreement on May 17, 2016, to define the terms and conditions for the highway improvement project (PROJECT) to perform Project Initiation Document (PID) phase activities for US 101/Blossom Hill Road Interchange modification.
- 2. CITY has recently decided that National Environmental Policy Act (NEPA) clearance should be added to the PROJECT activities.
- 3. PARTNERS now wish to enter into First Amendment to include NEPA clearance to the PROJECT scope. There would be no change to the funding on this Agreement.

IT IS THEREFORE MUTUALLY AGREED:

- 4. Article 5 under **RECITALS** section of the Agreement is hereby replaced in its entirety to read as follows:
 - 5. The estimated date for COMPLETION OF WORK is April 30, 2019.
- 5. New Article 9a under **RESPONSIBILITIES** section of the Agreement is hereby added to read as follows:
 - 9a. CALTRANS is the NEPA lead agency for PROJECT.
- 6. New Article 23a under **SCOPE** section of the Agreement is hereby added to read as follows:
 - 23a. CALTRANS will be the NEPA Lead Agency. CALTRANS will assess PROJECT impacts on the environment and CITY will prepare the appropriate level of environmental documentation and necessary associated supporting investigative studies and technical environmental reports in order to meet the requirements of NEPA. CITY will submit to CALTRANS all investigative studies and technical environmental reports for CALTRANS' review, comment, and approval as the NEPA Lead

- Agency. The environmental document and/or categorical exemption/exclusion determination, including the administrative draft, draft, administrative final, and final environmental documentation, as applicable, will require CALTRANS' review, comment, and approval as the NEPA Lead Agency, prior to public availability.
- 7. New Article 23b under **SCOPE** section of the Agreement is hereby added to read as follows:
 - 23b. When required, CALTRANS, as NEPA Lead Agency, will conduct consultation and coordination and obtain, renew, or amend approvals pursuant to the Federal Endangered Species Act, and Essential Fish Habitat.
- 8. New Article 23c under **SCOPE** section of the Agreement is hereby added to read as follows:
 - 23c. When required, CALTRANS, as NEPA Lead Agency, will conduct consultation and coordination approvals pursuant to Section 106 of the National Historic Preservation Act.
- 9. **SCOPE SUMMARY** of the Agreement is hereby replaced in its entirety by **SCOPE SUMMARY-A1**, attached hereto and made a part of First AMENDMENT.
- 10. Unless specifically defined herein, the capitalized terms used in this First Amendment shall have the meanings as defined in the Agreement.
- 11. Except as herein amended, all other provisions of the Agreement, including any exhibits and subsequent amendments thereto, shall remain in full force and effect.
- 12. If any provision of the Agreement, as amended by this First Amendment, is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remaining provisions shall continue in full force without being impaired or invalidated in any way.
