- (1) A Purchase and Sale Agreement with the County of Santa Clara for the sale of the properties located at 1072-1082 Vermont Street, San José 95126, further identified as Assessor's Parcel Numbers 230-42-077 and 230-42-078, and 6066 Monterey Highway, San José 95138, further identified as Assessor's Parcel Number 678-03-036, for a total sales price of \$8,000,000; and

Chris Burton, Director, Planning, Building and Code Enforcement, responded to questions from Council

Eric Lentz and David Witkowski, speaking on behalf of the applicant, provided comment to the Council.

<u>Motion</u>: Councilmember Bien Doan made a motion, which was seconded by Councilmember Peter Ortiz, to defer the PDC24-036, PD23-013 & ER23-141 – Planned Development Zoning District and Planned Development Permit for Certain Real Property Located at 2919 South King Road item until further community engagement is conducted.

<u>Friendly Amendment:</u> Mayor Matt Mahan proposed a friendly amendment to specify that community engagement would include holding a community meeting for those that signed a petition and those that are interested, before coming back to Council for approval. The maker of the motion and the seconder approved the Friendly Amendment.
