Proposed Project File No. T17-026 – Vesting Tentative Map to consolidate 3 lots into one for 304 residential and common condominiums and 10 commercial condominiums for an 18-story mixed use high-rise building with 302 units and approximately 10,000 square feet of commercial space approved under Special Use Permit File Number SP17-023 (the Tentative Map is the only permit under Appeal). The project is on a 0.77 gross acre site, in the DC Downtown Primary Commercial Zoning District, located at the northeast corner of Bassett Street and Terraine Street (199 Bassett Street) (Trenka LLC, Owner).
