Conduct a public hearing on the appeal of the Director's Decision dated June 9, 2025 sustaining the May 2, 2025 Revised Compliance Order, which required the Property Owner of 2784 Monterey Road to rescind the rent increases in excess of the allowable annual increase amount under the Mobilehome Rent Ordinance (SJMC Chapter 17.22), return all rent amounts collected from residents of Western Manufactured Housing Community in excess of the allowable annual increase, rescind all Notices to Pay or Quit based on amounts in excess of the allowable annual increase and dismiss any unlawful detainer actions (eviction lawsuits) filed on the basis of unpaid rent amounts in excess of the allowable annual increase, by May 16, 2025.

Recommendation: Issue an administrative order as set forth in the Staff Report dated September 23, 2025.

- b. **1215 CAMINO RAMON (429-13-071) APPEAL OF NOTICE TO REGISTER**  
**(Angel Esparza, Code Enforcement Inspector/ Sharma Samarinder, Property Owner)**

The Director of Planning, Building and Code Enforcement requests a hearing to review the Notice to Register issued and sent to the Property Owner(s) for the blighted and vacant property at 1215 Camino Ramon on August 13, 2025, and the Property Owner's Appeal of Notice to Register, received on August 22, 2025.

Recommendation: Affirm the Notice to Register the Subject Property (into the Neglected and Vacant Building Monitoring Program) actions on August 13, 2025, as set forth in the Staff Report dated June 20, 2025.
