**A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN JOSE APPROVING THE ADJUSTED CAMPAIGN  
CONTRIBUTION LIMITS IN ACCORDANCE WITH  
SAN JOSE MUNICIPAL CODE SECTION 12.06.210D**

**WHEREAS**, on November 1, 2011, the San José City Council (“City Council”) adopted Ordinance 28985, amending certain sections of Title 12 of the San José Municipal Code (“SJMC”); and

**WHEREAS**, under Section 12.06.210.D of the SJMC, as amended by Ordinance 30231, the City Clerk is directed to recalculate the Campaign Contribution Limits 280 days before the regularly scheduled primary municipal election to determine if the cost of living, as shown on the Consumer Price Index (CPI) for the San Francisco-Oakland-Hayward area, has increased during the “adjustment period” as defined in Section 12.06.210.D of the SJMC; and

**WHEREAS**, if the calculation results in an amount that is higher than the previously established Campaign Contribution Limits when rounded to the nearest \$100, the City Clerk will then increase the Campaign Contribution Limits established in SJMC Section 12.06.210.A (Council candidate contribution limit) and SJMC Section 12.06.210.B (Mayoral candidate contribution limit) by the percentage increase rounded to the nearest \$100, and recommend that the City Council adopt a resolution specifying the adjusted Campaign Contribution Limits; and

**WHEREAS**, as required under SJMC Section 12.06.210.C, the post-election contribution limit shall be the same as the limits established in SJMC Section 12.06.210.B, as may be adjusted by City Council Resolution; and

**WHEREAS**, the calculations below reflect the change in the Campaign Contribution Limits directed by Section 12.06.210.D of the SJMC:
