



**MINUTES OF THE
PUBLIC SAFETY, FINANCE AND STRATEGIC SUPPORT COMMITTEE
AND MEETING OF THE WHOLE**

SAN JOSE, CALIFORNIA

THURSDAY, SEPTEMBER 19, 2019

The Public Safety, Finance and Strategic Support Committee and Meeting of the Whole of the City of San José convened in regular session at 1:34 p.m. in the Council Chamber, Council Wing, City Hall.

PRESENT: Councilmember Raul Peralez, Chair; Vice Mayor Chappie Jones, Vice Chair; Councilmember Magdalena Carrasco (1:57); Councilmember Sylvia Arenas (1:41), Councilmember Sergio Jimenez, Members.

REPORTS TO COMMITTEE

1. Police Department Operations and Performance Bi-Monthly Status Report (Police)

Police Lieutenant Paul Cook offered a presentation, covering Citywide crime statistics, crime trends and emerging issues such as the Justice Assistant Grant. He responded to questions from the Committee.

Action: Upon motion by Vice Mayor Chappie Jones, seconded by Councilmember Sergio Jimenez and carried unanimously, the Police Department Operations and Performance Bi-Monthly Status Report was accepted.

Police Lieutenant Todd Trayer provided a presentation on ongoing academy recruitment campaign for officers, dispatchers and the records division.

Discussion followed, and Director of Employee Relations/Human Resources, Jennifer Schembri responded to questions. Councilmember Sergio Jimenez requested a staffing comparison breakdown.

Vice Mayor Chappie Jones left the meeting at 2:53 p.m.

Action: Upon motion by Councilmember Sergio Jimenez, seconded by Councilmember Sylvia Arenas and carried unanimously, the Cardroom Compliance with Title 16 of the San José Municipal Code Gaming Control Regulatory Program and Impact of Cardroom Gambling on Crime Annual Reports were accepted. 5. Procurement Card Expenditures Audit Report (City Auditor)


Documents Filed: Memorandum from City Auditor Joe Rois, dated September 12, 2019, providing the Procurement Card Expenditures Audit Report.
