### **RECOMMENDATION**

### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds in Special Event Accounts.

The Music in the Valley Festival will be held on April 30, 2023 at the Camden Community Center and sponsored by Councilmember Pam Foley, and will be free and open to the public. This special event brings together residents from District 9 and the City of San Jose to enjoy the performing arts as well as children's activities run by the Camden Community Center staff and local food and drink vendors.

### **ANALYSIS**
