<u>File No. GPT25-002.</u> Major Strategy #12, Policy IP-2.5, and Policy IP-2.11 in the Envision San Jose 2040 General Plan 2040 Land Use/ Transportation Diagram are hereby amended as follows:

- 1. **Major Strategy #12** Periodic Major Review Ensure that the Plan addresses the current community context and values and closely monitor the achievement of key Plan goals through a periodic major review of the General Plan and the use of Plan Horizons to phase implementation of the Plan over time. The Plan provides a road map for the development of new Urban Village areas and gives highest priority to the location of new housing growth in the Downtown, connecting transit corridors, BART station area, and North San José. The Envision General Plan establishes a 4-year Major Review cycle, which provides an opportunity for a community stakeholder task force or advisory group, and the City Council to evaluate significant changes in the planning context and the City's achievement of:
 - Planned job and jobs to employed resident (J/ER) ratio goals
 - Implementation of the Urban Village concept
 - Environmental indicators, including greenhouse gas reduction
 - Affordable housing needs

The Plan's policies include flexibility to allow the implementation of Urban Villages to be responsive to market conditions, while meeting overall Plan objectives.

- 2. **IP-2.5** During each Major Review of the Envision General Plan evaluate input provided by the reconvened Task Force or advisory group pursuant to Policy IP-2.11, and achievement of the following key General Plan goals to inform the City Council's decision, regarding needed changes, or to increase the number of residential units available for non-specific Urban Village areas:
 - a. Jobs/Housing Balance Demonstrate improvement of the City's jobs to employed resident ratio (J/ER) consistent with achievement of 1.0 job per

- Fiscal Sustainability Demonstrate sustainable improvement above 2010 levels in the level of service for City services provided to the San José community.
- c. Housing Supply Verify that there is adequate capacity to meet San José's Regional Housing Needs Allocation for the upcoming 4-year term.
- d. Infrastructure Confirm that adequate infrastructure and service facilities, especially transit, exist or that a secure plan for them is in place to support the planned jobs and housing capacity.
- 3. **IP-2.11** Reconvene the Envision San José 2040 Task Force During each Major Review of the Envision General Plan, convene a Task Force or an advisory group, such as the Planning Commission, that to provide provides a public forum for community and stakeholder engagement in reviewing and evaluating success in the implementation of this General Plan and recommending any mid-course actions needed to achieve its goals.
