(b) As part of the 2023-2024 Proposed Budget development process, in context of the City’s budgetary position and other critical City Council priorities, consider the following approaches to maintain quality of life in neighborhoods surrounding current and future Emergency Interim Housing and Bridge Housing Community sites through the provision of dedicated monitoring, reporting, blight reduction, community engagement and housing resources to communities within a half-mile of existing Emergency Interim Housing/Bridge Housing Community sites, including: (1) Housing outreach vendors to ensure weekly case management style homelessness outreach and associated housing resources for individuals experiencing homelessness; (2) Illegal dumping, graffiti, and vehicle abatement programs to ensure 48-hour removal of illegal dumping and graffiti, and ensure a 2-3 day response time for the vehicle abatement program; (3) Dedicated encampment services to maintain rights of way, provide trash service twice per week, and ensure

Deputy City Manager Omar Passons; Director of Housing Jacky Morales-Ferrand; Deputy Director Ragan Henninger; Director of Parks, Recreation & Neighborhood Services Jon Cicirelli provided the presentation and responded to questions.

Public Comments: 23 members of the public offered public comments.
