The Berryessa Flea Market is a jewel for the City of San Jose, and I'm greatly supportive of the efforts to preserve the Flea Market. I support the <u>5/9/25 Memorandum from Ortiz, Cohen, Casey & Campos</u>.

I believe that Recommendation 2.a.iv.1. is particularly crucial. The closer that the Flea Market stays to its current location, the better. And the best-case scenario is that the Flea Market stays in its current location. I am supportive of high-density housing in the Berryessa Urban Village, but this doesn't need to be an either/or situation. We can build high-density housing and keep our great Flea Market on site.

So in addition to Recommendation 2.a.iv.1., I would like to see the City use the tools at its disposal to keep the Flea Market on site. Are there any carrots that the City can use to influence the property owner to keep the Flea Market on site? Are there any sticks that could make it harder for the property owner to evict the Flea Market, or at least make it less economical? Please use any of the tools that you have.

On the other side of town, at Diridon Station, the City is making a multi-decade plan to redevelop that station area to attract a station-serving retail businesses economy that doesn't exist today. Berryessa Station already has the retail business economy for a successful TOD / Urban Village! Let's not lose the great thing that we have, and then have to rebuild that economy from nothing.

Keeping the Flea Market at its current location, or elsewhere directly adjacent to the BART station, would be a win-win-win for everyone involved:

- The Flea Market vendors would continue to have access to their current customer base, would gain
 many new customers as the Berryessa Urban Village is developed and BART SVII is completed, and
 wouldn't have to suffer the impacts of a relocation.
- Transit riders have a place to buy food or go shopping before or after their journey. The location is well
 connected to transit: besides the BART, there are four frequent bus lines that make stops at the transit
 center
- Residents of the Berryessa Urban Village will have access to fresh food, shopping, cultural events, and
 more, all in one convenient location. The Flea Market will serve as an anchor location for the Berryessa
 Urban Village, making it a desirable, interesting place to live.
- The Flea Market is well-connected to the bicycle network, and to the future trail network. It presently
 connects to the Penitencia Creek and Coyote Creek trails, and will be easily accessible from potential

future alignments of the Coyote Creek, Lower Silver Creek, and Five Wounds trails.

- The City and the property owners benefit from having an uninterrupted center of major commercial activity, compared to a potential future site for housing or a potentially relocated Flea Market.
- The City and the property owners can still achieve their goals for building lots of housing units in the Berryessa Urban Village. The Flea Market site itself has three large, under-utilized surface parking lots that would have to be developed anyway to fit the Urban Village context. Large amounts of housing can be built there, without needing to relocate the Flea Market. And much of VTA's property is also under-utilized and ripe for high-density redevelopment.
 - Alternatively, a phased development approach, could allow the entire property to be developed, while allowing the Flea Market to live on as ground-floor or indoor retail in the new development.

If staying near Berryessa BART is impossible, could we think outside the box to make it possible for the Flea Market to relocate somewhere near Diridon Station / Downtown West, or somewhere near the future 28th Street / Little Portugal BART station? Perhaps there are partnerships with Caltrain, VTA, or an enthusiastic private property owner that could allow the Flea Market to relocate to a different regional transit hub, to coexist and support (not replace) high-density housing near transit.

This is a critical moment. We urge our city leaders to act swiftly and boldly to preserve the economic and cultural legacy of the Berryessa Flea Market.
