Purpose:

The City of San José is part of a national learning network, Reimagining the Civic Commons (RCC), which convenes stewards, operators, funders, and advocates of parks, public spaces, and civic institutions to share knowledge, access resources, and build a movement for place-based community uplift. Every year, RCC hosts several Studios and Learning Journeys to showcase the work of a particular city.

Reimagining the Civic Commons is a national initiative demonstrating how strategic investments in public spaces can foster social connection, build trust, and support more resilient, equitable communities.

The program brings together leaders from across the country to explore how parks, libraries, trails, and other civic assets can be reimagined to serve the public good. As a participant, Councilmember Mulcahy will share San José's strategies for inclusive economic development and learn best practices from other cities. His involvement will help inform future projects that enhance quality of life, support community cohesion, and contribute to equitable public space planning in San José.
