BACKGROUND

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Santa Visits Alviso Holiday event will be held on Saturday, December 10, 2022 at George Mayne Elementary School and the Alviso Youth Center, 5040 N. First Street, and will be sponsored by Councilmember David Cohen. Both events are free and open to the public.

ANALYSIS

In observance of existing fundraising disclosure requirements, Councilmember David Cohen will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
