City Attorney, Nora Frimann announced that the City renewed its authority to join the Amicus Brief to prevent gun violence, regarding the City of Chicago v. Westfourth Sports Inc, Case No. 1-23-1908. Regarding the appeal of the decision against the City of Chicago that brought an action against a licensed gun business that was not following federal protocols to determine whether or not gun purchases were being made as straw purchases.

Adopt a resolution authorizing the City Manager or her designee to negotiate and execute a lease agreement, and all documents necessary to effectuate the lease, between the City of San José, a municipal corporation of the State of California, as Landlord, and the County of Santa Clara, a political subdivision of the State of California, as Tenant, for the continued use of approximately 10,000 square feet of space at the City-owned property located at 1608 Las Plumas Avenue, also known as the San José Environmental Innovation Center, allowing for an initial term of three years at a rental rate of \$314,000 per year plus operations and maintenance costs of \$78,000 for the first year, \$80,340 for the second year, and \$82,750.20 for the third year, totaling \$1,183,090.20 for the initial term, with four options to extend for an additional three years each at a rental rate of \$314,000 for each year of the option terms, exclusive of the operation and maintenance cost, which shall be determined upon the commencement of each option term.

Councilmember Torres expressed his concerns with the allegations brought to his attention regarding employee wage theft and worker safety.

Councilmember Ortiz expressed his concerns with the allegations brought to his attention regarding the labor compliance investigation and the miss-classifications of workers.

Councilmember Ortiz called down Erica Valentine (Local 393) to speak at the podium regarding the allegation raised. She requested an extension on the item.

<u>Motion</u>: Councilmember Ortiz made the motion to defer action on the Item until August 2024. Councilmember Torres seconded the motion.

Councilmember Cohen requested clarification from Erica Valentine, regarding the PRA.

Action: Upon motion by Councilmember Peter Ortiz, seconded by Councilmember Omar Torres, the *motion failed* to defer action on the Item until August 2024. (3-6-2; Noes: Mahan, Kamei, Cohen, Doan, Foley, Batra; Absent: Jimenez, Davis)

Mayor Mahan stated Item 2.12 was not deferred and the Item would be moved along with the rest of the Consent Calendar when the motion is made.

Adopt a resolution authorizing the City Manager or her designee to:

- (a) Negotiate and execute an agreement and purchase order with Hasler Enterprise Solutions, LLC (Irvine, CA) for a Youth Services Data Management Solution for the City's Parks, Recreation and Neighborhood Services Department, with an initial three-year term beginning on or about July 1, 2024, and ending on or about June 30, 2027, or as may be adjusted to align with the software renewal term, with a maximum compensation not to exceed \$529,372;
- (b) Approve a contingency of \$52,937 for unanticipated and related services, subject to the appropriation of funds; and
- (c) Exercise up to four one-year options to extend the term of the agreement for a possible maximum term of seven years, subject to the appropriation of funds.

Also including the following timeline: The first segment of construction or incentive would be for a five year period, and the second level of incentive would be for a two year period, for a total of seven years.

Accept staff's recommendation with the following modifications:

- 1.) Remove fixed timelines from the program's phasing and extend the Downtown High-Rise Fee Waiver program to the next 10,000 units that receive building permits and pass first inspection within 12 months of obtaining a building permit within the following framework (as outlined in Attachment A below):
 - a.) Phase 1: Provide a 100% reduction of construction taxes and a 50% reduction in parks fees for the first 2,000 units.
 - b.) Phase 2: Provide a 50% reduction of construction taxes and a 30% reduction in parks fees for the next 2,000 units.
 - c.) Phase 3: Provide a 50% reduction of construction taxes for the final 6,000 units.

- (4) Authorizing the Director of Housing or their designee to negotiate and execute loan documents and all other documents, including any amendments thereto, related to City financing for Santa Teresa Multifamily development.
- (b) Adopt the following Fiscal Year 2023-2024 Appropriation Ordinance amendments in the General Fund:
- (1) Decrease the Measure E-40% Extremely Low-Income Households Reserve by \$3,650,000;
- (2) Decrease the Measure E 30% Low-Income Households Reserve by \$3,600,000;
- (3) Increase the Measure E-40% Extremely Low-Income Households appropriation to the Housing Department by \$3,650,000; and
- (4) Increase the Measure E-30% Low-Income Households appropriation to the Housing Department by \$3,600,000.

CEQA: Exempt per Public Resources Code Section 21080(b)(1) and CEQA Guidelines Section 15369, Ministerial Project pursuant to Government Code Section 65913.4, File No. ER20-109. Council District 10. (Housing/City Manager)

Erik Solivan, Director, Housing Department offered the presentation and responded to questions.

Public Comment: Blair Beekman provided public testimony regarding the item.

Action: Upon motion by Vice Mayor Rosemary Kamei, seconded by Councilmember David Cohen, and carried unanimously, (a) **Resolution No. RES2024-278** was adopted, regarding actions related to a loan commitment for Santa Teresa Multifamily Located at 5885 Santa Teresa Boulevard for the Development of a New Affordable Rental Housing Development; and (b) 2023-2024 Appropriation **Ordinance No. 31108** was adopted, regarding the amendments in the General Fund. (9-0-2; Absent: Jimenez, Davis)

8.4 Potential Supportive Outdoor Sleeping/Temporary Alternative Sleeping Sites and Related Implementation Actions.

- (3) Award and execute contract(s) for the construction of project(s) for the purpose of supportive outdoor sleeping and/or basic needs sites at various locations to the lowest responsive, responsible bidder in an amount not to exceed \$5,000,000 for each site;
- (4) Award and execute contract(s) for the construction of interim housing projects at Cerone and/or Cherry sites to the lowest responsive, responsible bidder in an amount not to exceed \$25,000,000 each;
- (5) Decide any timely bid protest(s) and make the City's final determination as to the lowest responsive bidder that is responsible as needed to award the contract(s); and (6) Approve contingency in the amount of 10% of the contract amount for each contract. CEQA: Determination of Consistency with the Mitigated Negative Declaration for the

Emergency Interim Housing Programs project (Resolution No. RES2023-380), File Nos. ER22-198 and ER24-015. (Public Works/Housing/City Manager)

Matt Loesch, Director, Public Works Department; Erik Solivan, Director, Housing Department; and Omar Passons, Deputy City Manager offered the presentation and responded to questions.

<u>Public Comment</u>: Bill Schroh (History of San José), Hong Cao (Viet Museum), Sylvia Carroll (History Park), Ocie Tiusley (AAHH), Ken Middlebrook (History San José), Robert Walker, Joe Machado (Portuguese Museum), Blair Beekman, Mike Sodergren (PAC SJ), and Yvonne Martinez (Morgan Hill Councilmember) provided public testimony regarding the item.

Motion: Councilmember Pam Foley made the motion to move approval of the following:

- Joint memorandum co-authored by Mayor Mahan, Councilmember Jimenez, Councilmember Cohen, and Councilmember Pam Foley dated June 14, 2024

Councilmember Omar Torres seconded the motion.

<u>Friendly Amendment</u>: Councilmember Arjun Batra requested that Staff report back to Council after the feasibility analysis has been completed and provide a report with what they have found to be feasible and suitable for each site. The friendly amendment was *not accepted* by the maker of the motion and seconder.

Councilmember Pam Foley requested that Staff make a commitment to engage the designated Council Office as a partner every step of the process once the site is narrowed down, so the Council office can work with Staff to engage and work with their Community to gain acceptance. Staff stated that was feasible.

Jennifer Maguire, City Manager offered clarifications regarding the Staff recommendations.

<u>Friendly Amendment</u>: Councilmember Arjun Batra requested that the Singleton Site be included on the list of Potential Sites for further feasibility analysis to be determined by Staff. The friendly amendment was *not accepted* by the maker of the motion and seconder.

<u>Substitute Motion</u>: Councilmember Bien Doan moved approval of the following as part of the substitute motion:

- Approval of all 4 Council joint memorandums.
- Include the Singleton Site to study the feasibility of its remediation for the news as a shelter, but the Singleton Site and any site within all of Kelly Park as an actual safe sleeping site.
- *Including recommendations (b5) and (b6) from the Staff memorandum.*

Councilmember Batra seconded the substitute motion.

<u>Friendly Amendment</u>: Mayor Mahan requested that Council include recommendations (b5) and (b6) from the Staff memorandum as part of the final action on the item.

<u>Vote on the Substitute Motion</u>: On a call to question, the substitute motion failed. (3-6-2 Noes: Kamei, Torres, Cohen, Ortiz, Candelas, Foley; Absent: Jimenez, Davis)

Councilmember Foley accepted the Mayor's Friendly Amendment, to include recommendations (b5) and (b6) from the Staff memorandum as part of the underlying motion on the floor. The seconder also accepted the friendly amendment.

<u>Friendly Amendment</u>: Councilmember Doan requested that Councilmembers have the ability to not approve a site from being built (current list of 8 sites) after opposition from the community during outreach. Evaluate, and incorporate where appropriate, procurement and contracting strategies that align incentives, establish clear performance metrics, and determine penalties for contractors and subcontractors, and any other feasible innovative project delivery methods with the goal of encouraging project teams to deliver the Cerone and Cherry EIH communities on time.
 - d.) Provide an informational memorandum as part of the Citywide Homelessness Annual Report updating Council on the chosen delivery approaches, project milestones including dates for a groundbreaking, outreach phase, and timeline for resolving encampments and the overall committed timelines for delivery for both Cherry and Cerone EIH communities.

Including acceptance of the joint memorandum co-authored by Councilmember Jimenez, Councilmember Torres, and Councilmember Cohen dated June 14, 2024 recommending the following:

Approve the Memo from the Mayor and Councilmembers Jimenez, Torres, Cohen, and Davis with the following modification: *Remove* the South Coyote Valley site (Parcel Number 725-01-023) from the list of Potential Sites for Further Evaluation.
