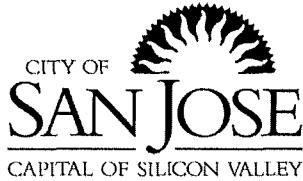

RECOMMENDATION

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Mamapalooza will be held on May 21, 2018 at Evergreen Village Square and sponsored by Councilmember Arenas. This special event brings together mothers, children, and families for a fun-filled event outdoors, and to celebrate Mother's Day.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Arenas will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). 
