A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE (1) APPROVING THE WILLOW GLEN COMMUNITY BENEFIT AND IMPROVEMENT DISTRICT ANNUAL REPORT FOR FISCAL YEAR 2025-2026 AS FILED, OR MODIFIED BY COUNCIL, CONFIRMING AND LEVYING THE INDIVIDUAL ASSESSMENTS AS FILED OR MODIFIED BY THE CITY COUNCIL; AND (2) DIRECTING THE DIRECTOR OF PUBLIC WORKS TO DELIVER THE ASSESSMENT ROLL TO THE COUNTY OF SANTA CLARA FOR COLLECTION WITH THE PROPERTY TAXES

WHEREAS, the Willow Glen Community Benefit and Improvement District ("Willow Glen CBID") was approved by property owners and adopted by the Council of the City of San José ("City Council") on December 8, 2008 for a fifteen-year period to raise funds for enhanced services for the downtown Willow Glen area; and

WHEREAS, on June 4, 2024, the Willow Glen CBID was expanded and renewed for a fifteen-year period beginning January 1, 2025, and ending December 31, 2039; and

WHEREAS, pursuant to the Chapter 14.31 of Title 14 of the Municipal Code of the City which incorporates and modifies the California Streets and Highways Code "Property and Business Improvement District Law of 1994", and the agreement between the City of San José ("City") and the Willow Glen Business Association, the Willow Glen Community Benefit Improvement District Annual Report for Fiscal Year 2025-2026 ("Annual Report"), was submitted to the City Council; and

WHEREAS, for Fiscal Year 2025-2026, the Annual Report recommends an assessment increase of 2.76% on all parcels; and

WHEREAS, the total maximum assessment levy for FY 2025-2026 will be approximately \$466,476; and

4. The Director of Public Works is authorized to deliver the assessment roll to the

County of Santa Clara for collection with the property taxes.
