Respected City leaders:

I'm writing you regarding item 7.1 on tomorrow's city council agenda. As the coordinator of Beautify Almaden which I established in 2018 and whose volunteers have spent more than 1000 hours removing over 840 bags of litter in the Almaden area over the course of that time, I think it's important for you to know what I've learned about the biggest source of litter in our community. It's time to move beyond simply coordinating volunteer trash removal events

to addressing its root causes:

Fully 50% of what we collect in Almaden blows out of uncovered truck beds. We collect everything from contract supplies (booties, gloves, appliance boxes, paint debris, even ladders) to garden supplies (pots, gloves, fertilizer bags, etc). We desperately need your help to ENFORCE or CREATE covered truck ordinances in San Jose.







The absence of these trees has become increasingly noticeable across key corridors like King & Story, West San Carlos St., and East Santa Clara St., areas that benefit from the elegance and character that palms bring. By including Washingtonia Robusta palms in replanting partnerships, San Jose can retain and even elevate its unique identity, attracting both residents and tourists who contribute to our local economy.

If we do not see immediate action on this matter, we will continue to advocate for the inclusion of Washingtonia Robusta palms in upcoming city meetings. We are committed to working with the city to ensure that San Jose's historical character and visual appeal are preserved for future generations.

Thank you for considering this request. We look forward to a collaborative effort to make San Jose a more vibrant city.

Dear Members of the San Jose City Council, City Planning and Development Teams, City Arborists, and Other Relevant Officials,

On behalf of several neighborhood associations and long-time San Jose residents, we are writing to express our collective concern about the disappearance of Washingtonia Robusta Palm Trees, also known as Mexican Fan Palm Trees, in the City of San Jose. These trees are iconic to our city's landscape, particularly in areas where they have been planted to beautify and rejuvenate our streets.

With new developments rapidly reshaping our urban environment, these iconic palm trees are being removed and, in many cases, not replaced. This absence is profoundly altering the city's visual identity. Locations such as the King & Story and Story Road Corridor, West San Carlos St., Almaden Blvd., East Santa Clara St. near Five Wounds Church, and West Santa Clara near the SAP Center and Hotel De Anza have long benefited from palm lined streets, which contribute to San Jose's image as a thriving, beautiful city, often dubbed the "Los Angeles of Northern California." – "Dutch" Hamann, 1965

We strongly urge the City of San Jose to prioritize the preservation and replanting of Washingtonia Robusta Palm Trees in future city planning and developments. In particular, we request that the city arborist ensures that this species continues to be included in replanting efforts. By not including these palms, we are losing an essential part of San Jose's historical identity and visual appeal. The distinct look of palm lined streets has been integral to our city's character for decades, and it would be a disservice to our community to let that disappear.

Additionally, we are deeply concerned about the recent uptick in arson incidents targeting these palm trees. When these trees are destroyed, they are often not replanted, leaving gaps in our streetscape and further diminishing the historical feel of our neighborhoods. We believe the city should actively invest in replanting these trees and continue using them to beautify San Jose, helping it maintain the look and feel of a major city separate from the rest of the Bay Area.

By preserving and replanting Washingtonia Robusta palms, we can ensure that San Jose remains a city with a unique and beautiful identity. We hope the city will consider these suggestions and make a commitment to preserving the iconic palm lined streets that have helped define San Jose for so many years.

Thank you for your time and consideration. We look forward to seeing San Jose thrive while staying true to its historical roots.

Figure it out, it shouldn't take 4 years to solve this problem.


Ita' not our responsibily to clear these streets.
