**A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE APPROVING THE PHASE III SANITARY SEWER MASTER PLAN REPORT RECOMMENDING SANITARY SEWER CAPACITY IMPROVEMENT PROJECTS TO MEET THE CITY'S SANITARY SEWER LEVEL OF SERVICE POLICY, ENVISION SAN JOSE 2040 GENERAL PLAN GROWTH PROJECTIONS, AND THE CALIFORNIA STATE WATER RESOURCES CONTROL BOARD'S GENERAL ORDER FOR SANITARY SEWER SYSTEMS**

**WHEREAS**, the City of San José ("City") adopted the Envision San José 2040 General Plan, which includes goals to ensure adequate sanitary sewer infrastructure to meet existing and future growth needs; and

**WHEREAS**, the Department of Public Works has completed the Phase III Sanitary Sewer Master Plan analyzing the citywide all-main sewer system and identifying seventy-six (76) capacity improvement projects; and

**WHEREAS**, the Phase III Master Plan recommends projects to address existing deficiencies and support planned development, in alignment with City Council Policy 8-7 and the California State Water Resources Control Board's General Order; and

**WHEREAS**, the adoption of the Phase III Master Plan ensures continued compliance with local, state, and federal regulations governing sewer capacity and environmental protection; and

**WHEREAS**, by Resolution No. \_\_\_\_\_, the City Council adopted an Addendum to the Envision San José 2040 General Plan Final Program Environmental Impact Report (Resolution No. 76041) and the Supplemental Environmental Report (Resolution No. 77617) has been prepared by the City's Director of Planning, Building and Code Enforcement, in accordance with California Environmental Quality Act and concludes no

new or more severe environmental impacts would result from implementation of the Phase III Sanitary Sewer Master Plan; and

**WHEREAS**, approval of the Phase III Sanitary Sewer Master Plan will allow the City to proceed efficiently with implementation of vital infrastructure improvements without incurring additional environmental clearance costs;

**NOW, THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT:

The Phase III Sanitary Sewer Master Plan Report recommending sanitary sewer capacity improvement projects to meet the City's sanitary sewer level of service policy, Envision San José 2040 General Plan growth projections, and the California State Water Resources Control Board's General Order for Sanitary Sewer Systems is hereby approved.
