I support the memo by Councilmembers Arenas, Carrasco, and Cohen. Lake Cunningham has the potential to be an incredible destination on the east side. Unfortunately, it is not reaching that potential due to the contaminated water and lack of maintenance.

I went to bike around the park recently with my family members who have lived in San Jose for 50+ years and had never been to the lake. They both commented how nice it was to have an area that we can safely bike close to home, but also how dirty it was. The facilities were dirty, the grounds were incredibly dirty, and the newer exercise area had broken parts (which is unfortunate because I was delighted to see 3 or 4 people enjoying the functional machines). It would be great if the City cared about this park as much as the Rose Garden or parks in Almaden & Willow Glen.

I don't understand how we can't allocate funding for a priority like this, but continue to fund a \$40 million gym for the Police Department that we're supposed to "reimagine".

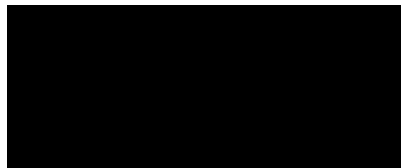

**Re: San Jose City Council 6/15/21 Agenda Item 3.12 Measure T: Support for Lake Cunningham Water Quality Investment**

Dear Mayor Liccardo and San Jose City Council Members,

Please approve the memorandum from Council Members Arenas, Carrasco, and Cohen to show your continued support for directing the remaining Measure T funds toward improved water quality. Improving the water quality at Lake Cunningham is important for the health of wildlife and humans and allows Parks Recreation and Neighborhood Services to reopen the area, permitting access to nature by residents of East San Jose.

Ongoing projects to improve access to nature and water quality in southern San Jose, with restoration work in Coyote Valley and with the Valley Water creek separation project for Almaden Lake in western San Jose, makes addressing the imperiled nature of Lake Cunningham in eastern San Jose an equitable priority for improving the City's water quality.

We recognize that water quality is related to the quality of land next to the water. Today the lake is encircled mostly by rocks and asphalt and very little native vegetation. Native wetland and riparian plants along the water's edge can filter contaminants away from the water. This will also enhance nature-based recreation activities (walking, jogging, birding, botanizing, photography).

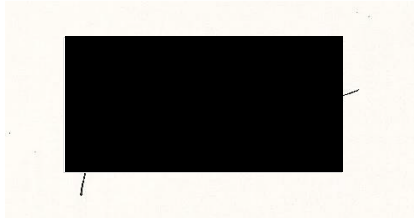
