SUBJECT: ARTS COMMISSION FISCAL YEAR 2022-2023 ANNUAL REPORT AND FISCAL YEAR 2023-2024 WORK PLAN

RECOMMENDATION

Approve the Arts Commission annual report for Fiscal Year (FY) 2022-2023 and work plan for FY 2023-2024 to comply with the City Municipal code about Boards and Commissions.

OUTCOME

With the approval of these priorities for FY 2023-2024, the Arts Commission will continue its work related to advising on matters about arts and culture to the City Council and the Office of Cultural Affairs, a division of the Office of Economic Development and Cultural Affairs (OEDCA). As a result of this work plan, the Arts Commission helps shape the City's policies related to the arts, arts grants, cultural facilities, outdoor special events, public art, and creative placemaking and advises on the implementation of *Cultural Connection: San Jose's Cultural Plan* with the community.

BACKGROUND

Under section 2.08.850 of the Municipal Code, the Arts Commission's nonexclusive functions, powers, and duties are to:

- a) Encourage the full artistic life of the city's culturally diverse community and the beautification of the City.
- b) Advise the Council on all matters affecting the arts and the beauty of the city, including the development, organization, and operation of municipal arts programs and facilities.
- c) Establish an effective liaison between the City and arts organizations, assess the needs

of arts organizations, and recommend to the City Council measures to promote the strength and cultural diversity of arts organizations. Advise the Council on appropriate policies and procedures for the distribution of city funding for the arts and make recommendations to the Council respecting grants and other funding to arts organizations.

- d) Advise the Council on appropriate policies and procedures for the distribution of City funding arts and make recommendations to the Council respecting grants and other funding to arts organizations.
- e) Advise the Council in coordination with appropriate boards and commissions on all matters related to public art, including the acquisition and placement of works of art as well as the maintenance, removal, relocation, or alteration of existing works of art in the city's possession, and perform all duties concerning the Art in Public Places Program as provided in Title 22 of this Code.
- f) Examine every two years the condition of the city's works of art and report to the Council with recommendations for their care, maintenance, and improvement.
- g) Render advice and assistance in the fields of art, aesthetics, and beautification to other city boards and commissions.
- h) Establish an effective liaison and cooperation between the city's arts programs and the programs of adjacent communities, the county, the region, the state, and the nation.

The Arts Commission convenes regular monthly meetings ten times per year; no meetings are held in July and December. The Commission has two standing committees, the Executive Committee and the Public Art Committee, both of which are regularly scheduled to meet six times per year on alternating months.

ANALYSIS

Throughout FY 2022-2023, all boards and commissions continued to reconvene using remote technology until transitioning to hybrid meetings in March 2023. FY 2022-2023 was a productive year for the Arts Commission in its continued role of advising City Council on matters about the arts and culture as detailed in the attached FY 2022-2023 Annual Report. Notably, the Arts Commission continued to steward the implementation of the Council-adopted *Cultural Connection: San Jose's Cultural Plan*.

The Arts Commission's key activities in FY 2022-2023 included:

- Discussed how the arts community can be best supported in its recovery from the pandemic
- Reviewed, discussed, and approved the proposed revisions to the 2023-2024 Cultural Funding Portfolio Guidelines
- Reviewed and accepted the panel's recommendation for the 2023 Creative License Ambassadors
