2.7 21-451 Amendment to the Coyote Valley Master Transfer and Conservation Agreement. - DROP

Councilmembers Carrasco and Arenas honored National Women's History Month, recognizing all the capable and resilient women who have come before us, paved the way and passed the torch to the next generation. They spoke to struggles during the pandemic and noted their hard work and perseverance in dealing with double standards.

Deputy City Manager, Kip Harkness presented the outcome of the 2021-2022 City Roadmap Round 2 Point Allocation, and Budget Director Jim Shannon explained how it would be folded into the budget exercise. Mr. Harkness noted that will be returning to Council on a quarterly basis for updates and on an annual basis for a 're-look', indicating it is a living document.

Item 3.5 was heard directly following this report.

3.3 21-456 Approval of the Fiscal Year 2021-2022 Mayor's March Budget Message.

(a) Conduct a Public Hearing on the FY 2021-2022 Mayor's March Budget Message.

(b) Approve the FY 2021-2022 Mayor's March Budget Message. CEQA: Not a Project, File No. PP17-010, City Organization and Administrative Activities resulting in no changes to the physical environment. (Mayor)

Deputy Director, Jeff Provenzano responded to questions regarding muni water rates. Deputy City Manager, City Manager's Office, Kip Harkness offered responses regarding the Mayor's memorandum.

Mayor Sam Liccardo opened the public hearing.

Public Comments: Forty members of the public provided public testimony, including: Josh Lord (External Affairs at California Volunteers), Reymundo, Mark Seeger (Glydways, Inc.), Jason Baker (SVLG), Blair Beekman, Jennifer Miller (San José State University), Kathryn Hedges, Speaker "5140", Alex Shoor (Catalyze SV), Jason Su (Guadalupe Garden Conservancy), Nicole Andreas, Deb Kramer, Frank (Academic Coffee and Downtown Association), Kevin McClellan (SV Small Business), Shawni Kleinhaus (Santa Clara Valley Audubon Society), Dan Mann, Bob Sipple (Guadalupe River Task Force & Conservancy Team), Jewel Buchanan (Neighborhood Services Commission), Bill Rancon Save Our Trails), Scott Largent, Molly McCleod, Adolfo Gomez, Brett Bymaster (Healing Grove Health Center), Hilary Thorsen (Library & Education Commission), James Carter (Neighborhoods Commission), Michele Mashburn, Nathan Ulse (San José Downtown Association), Trini, Trami Cron (Arts Commission), Justin Imamura (Trash Punx), Victoria, Smita Garg San José Arts Commission), Sandy Flores (Capitol Park Neighborhood Association), Mike Krause (D4 Neighborhood Association), Linda Gomez (Metro Ed), Steve Holmes (Clean Creeks Coalition), and Juan Carlos Araujo (Arts Commission & Empire Seven Studios).

Mayor Sam Liccardo closed the public hearing, and Council discussion followed.

<u>Motion</u>: Vice Mayor Chappie Jones moved approval of staff's recommendations, including Mayor Sam Liccardo's memorandum and Councilmembers Arenas and Esparza's memorandum dated March 12 with a bifurcation of Item #3. Councilmember Dev Davis seconded the motion.

Environmental Services Department Deputy Director Jeff Provenzano responded to questions from Councilmember Sylvia Arenas regarding the water bill rate notice and SB222. Assistant City Manager, Lee Wilcox provided clarifications regarding federal funding and policy options. Budget Director Jim Shannon spoke on adjustments to the budget.

Friendly amendments were presented by Councilmembers Arenas, Esparza, Foley and Peralez, including dropping Item #3 from the joint memo rather than bifurcating this item. Vice Mayor Chappie Jones and Councilmember Dev Davis accepted the friendly amendments as noted below.

<u>Action</u>: On a call for the question, the FY 2021-2022 Mayor's March Budget Message, including the March 8, 2021 memorandum from Mayor Sam Liccardo was accepted, directing the City Manager to submit a balanced budget for Fiscal Year 2021-2022, guided by the policy direction and framework of

priorities outlined in this March Budget Message, and noting this initial framework provides the City Manager with direction to prepare proposals for the Council's budget deliberations in May, and to formulate the Fiscal Year 2021-2022 Proposed Budget.

Also including the March 12, 2021 joint memorandum from Councilmembers Arenas and Esparza With changes as noted:

- 1. Define Include high-need neighborhoods in the Mayor's March Budget Message as Low Resource census tracts, designated by the California Fair Housing Task Force, as an additional tool to be evaluated for consideration in deploying services.
- 2. Utilize data collected by the technical lead, as proposed in the Mayor's March Budget Message Data Equity, to ensure an equitable standard of service is delivered across all communities including, but not limited to: response to blight and illegal dumping; programming and utilization of libraries, parks, community centers, and daycare facilities; emergency services response time; roadway conditions and repairs; access to public art; code enforcement; and economic development, business development, and workforce development services.
- 3. Refer any items in the Mayor's budget that have no budgetary impact to the Rules process for Council consideration.
- 4. Direct the City Manager to produce a Manager's Budget Addendum providing performance metrics for all currently budgeted and newly proposed Learning Loss and College and Career Readiness programs. Bring forward a comprehensive and strategic plan for COVID related learning loss for grades K-12.
- 5. Building upon the Mayor's Memo regarding Protecting Services to Our Low-Income Communities, direct the City Manager to produce a Manager's Budget Addendum on childcare and recreation services, including steps to continue PRNS's current expanded scholarship program for low-income COVID impacted families through the fiscal year and into the future.
- 6. Direct the City Manager to produce a Manager's Budget Addendum to integrate a community development model such as the "promotora" approach to high-need neighborhoods, leveraging Project Hope and the proposed Resilience Corps towards this effort.

Additionally, including an amendment from Councilmember Maya Esparza to add Coyote Creek with Guadalupe River Park funding, and an amendment from Councilmember Pam Foley to include exploration of a task force for people with disabilities. Also including a request from Councilmember Raul Peralez that the CMO's office return with an MBA that may include one-time funds used for a multi-year effort for the Office of Racial Equity, possibly serving those with disabilities under that same umbrella, such as with inclusion of an accessibility officer. 11-0.
