The Director of Planning, Building and Code Enforcement requests a hearing to consider the adoption of a proposed abatement order to require the property owner by the end of ten (10) calendar days of the date of service of the Board's resolution to abate severe blight and solid waste violations present in the front, side and rear yards including the dilapidated attached patio cover located at the rear of the home and the dead tree located in the rear yard of the single family residence and to recover all costs associated to City Contractor as well as all administrative costs.
