Conditional Use Permit to allow commercial truck sales, leasing, and repair in a 57,348-square-foot vacant building on an approximately 2.57-gross acre site located at 1015 Timothy Drive (C&G California Enterprises LLC, Owner). The proposed amendments would modify distance requirements from Cannabis retail businesses to schools, daycare centers, youth centers, community and recreation centers, and parks; eliminate the distance requirement between storefronts and add a standard to address concentration of cannabis retail businesses; remove the police beat restriction; and make other technical, non-substantive, or formatting changes within those sections. (City of San Jose, Owner). Council District: Citywide. CEQA: In accordance with the California Environmental Quality Act, an Addendum to prior Initial Study/Negative Declaration (PP21-002), as addended to, and prepared in conformance with the California Environmental Quality Act of 1970 (CEQA), as amended for this Ordinance under File Number PP23-001 (the "Addendum to Initial Study/Negative Declaration") and including State and local implementing regulations.
