The meeting was adjourned in memory of Thomas “Tommy” Nuñez, who passed away on April 24, 2026. A lifelong advocate for youth and a 30-year NBA referee, Tommy dedicated his life to encouraging young people to excel in both academics and athletics. As the founder of the National Hispanic Basketball Classic and the Tommy Nuñez Foundation, he brought together youth, including many from San José, to educate and empower them, raising awareness about the dangers and lasting consequences of drug use and dropping out of school.
