I am now partnering with The Freedom Angels.

We sent you a list of demands and other documents Thursday September 24<sup>th</sup>.

We will not stop.

We will not be silent.

We will not accept or comply with Dr. Sara Cody's draconian orders.

I have been negatively impacted by her orders because I cannot medically tolerate a mask. I was made to go on unpaid leave starting May 19<sup>th</sup>.

I have been hit hard financially because of this.

I was a productive and happy member of our community. I worked for my company in 6 different apartment communities in Santa Clara County. All of those apartment communities bring a lot of revenue to our county. (I

have been with my company for over 5 years. My previous job was also for a local company, for 6 years and the one before that was also in SJ for 5 years)

I built up a great rapport with many businesses in Midtown and downtown San Jose.

I have lost 15 pounds due to stress.

I miss going to church and the gym. Dr. Sara Cody has stripped our First Amendment right and that is unlawful and unacceptable!

I have gotten hassled at many stores because I do not and will not wear a mask.

Masks are BAD for our health and are 100% dehumanizing.

You MUST stop the madness!!

You can follow the lead of other counties.

The numbers do not match the draconian orders.

**Covid-19 has a 99.9% recovery rate!!!**

There are plenty of beds in the hospitals and enough PPE.

The county should NOT be spending millions of dollars on testing which is questionable and tracing. You are all invading our privacy!

There are many more people and programs that money could go to and should go to. People in this county are on the brink of homelessness and starvation!!

You are all misusing the CARES ACT money which is illegal.

What is WRONG with you?! How can you sleep at night?!

Our lives are filled with anxiety and stress. Many people have gone back to heavy drinking and drug use.
