Council Direction – June 26, 2018

June 26, 2018

Direct the City Manager and City Attorney to:

- ▶ Bring forward a measure that included annual cost of living adjustments, but also included Salary Setting Commission review and setting of base salaries for the Mayor and Councilmembers every five to ten years.
- ▶ Return with information from other major cities.
- ▶ Conduct additional polling.

Proposed Ballot Question

2018 Charter Amendments.

Shall the City of San José's Charter be amended to:

- ▶ Remove the Mayor and Council's ability to approve their salaries;
- ▶ Require the Salary Setting Commission to adjust the base salaries for the Mayor and City Council once every 10 years;
- ▶ Limit base salary increases after each 10-year adjustment to annual adjustments for inflation; and
- ▶ Align the City Charter with State law to allow the City Council to place competing ordinances on the same ballot in Municipal Elections?

Salary Setting Process: Other Cities

| Jurisdiction | Who Sets Salary | How Often? | Amounts |
|---------------|---|---|--|
| San Francisco | Civil Service Commission | Once every five years | Supervisors: \$121,606 Mayor: \$326,527 |
| San Diego | Salary Setting Commission rec. + Council vote. Considering change to tie to judicial salaries | Every two years | Council: \$75,386 Mayor: \$100,464 |
| Los Angeles | Controller ascertains & adjusts | Council: Equal to judges Mayor: 30% higher | Council: \$189,464 Mayor: \$246,303 |

Salary Setting Process: Other Cities (cont'd)

| Jurisdiction | Who Sets Salary | How Often? | Amounts |
|--------------|--|--|--|
| Sacramento | Compensation Commission | Annually | Council: \$63,272 Mayor: \$127,732 (2017) |
| Fresno | City Council | Cannot increase or decrease during elected's term | Council: \$65,000 Mayor: \$130,000 (2016) |
| Oakland | Council: Public Ethics Commission Mayor: City Council | Council: Annual, CPI, up to 5%. Mayor: Every 2 years, within 70%-90% of City Managers/CEOs of six CA cities | Council: \$91,018 Mayor: \$202,999 (2017) |

Proposed Process for Setting Mayor/Council Salaries

Next steps, if measure passes:

- ▶ **2019:** Salary Setting Commission sets 2019-2020 base salaries for Mayor and City Council without Council approval
- ▶ **2020-2021 to 2028-2029:** Adjustments to Mayor and Council salaries limited to CPI-U
- ▶ **2029:** Salary Setting Commission sets 2029-2030 base salaries for Mayor and City Council
- ▶ **2030-2031 to 2038-2039:** Adjustments to Mayor and Council salaries limited to CPI-U

Competing Ordinances

BACKGROUND AND
RECOMMENDATION

Competing Ordinance Background & Recommendation

- ▶ When a voter-sponsored initiative qualifies for the ballot, California law allows city councils to submit an alternative ordinance to the voters. If both pass, the measure getting the highest number of affirmative votes becomes law.
- ▶ Under Section 1603 of the San Jose City Charter, the San Jose City Council may not submit an alternative ordinance on the same ballot as a voter-sponsored initiative.
- ▶ Staff recommends removing this limitation from the City Charter and aligning with State Law.

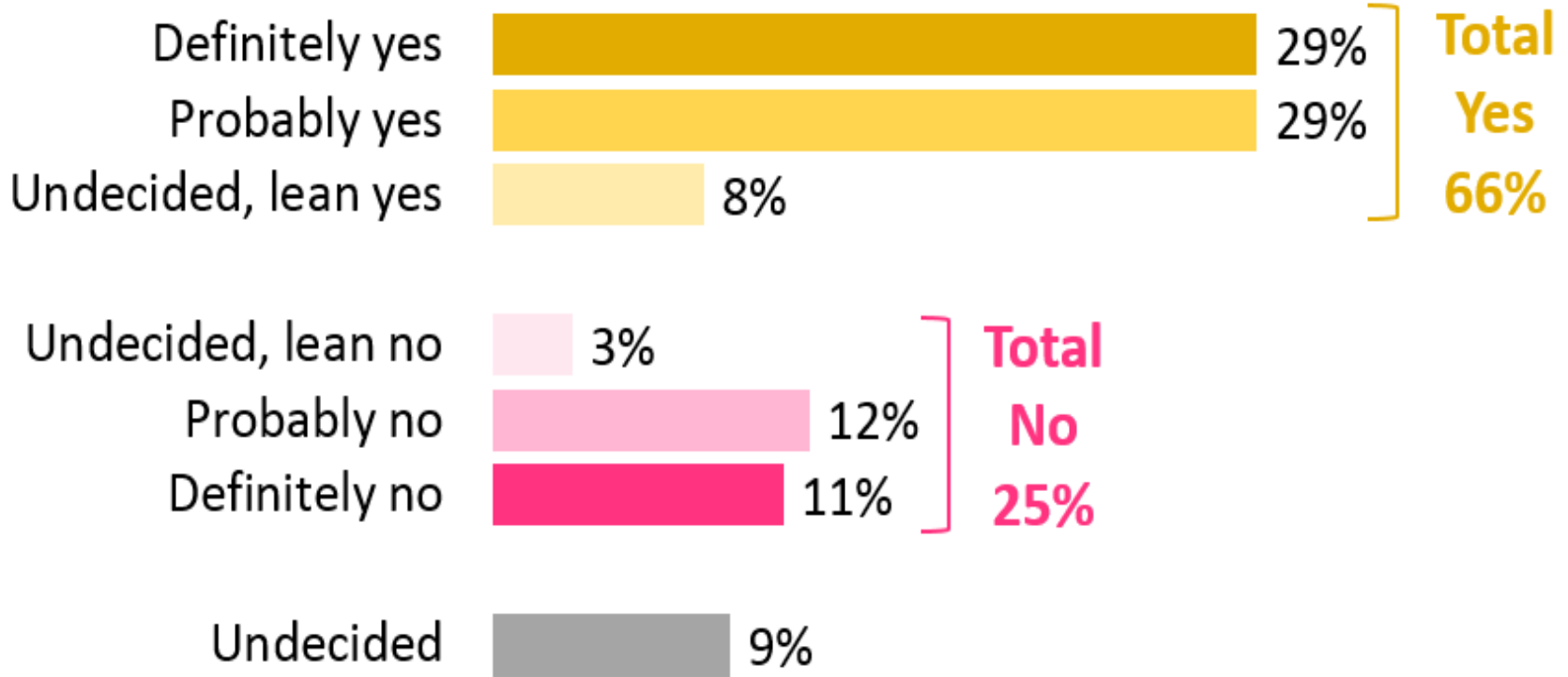

Timeline and Next Steps

- ▶ August 7, 2018 – Council decision on ballot measure & language
- ▶ August 10, 2018 – Registrar of Voters ballot measure deadline

If Council places measure on ballot:

- ▶ November 6, 2018 – Election Day

If measure passes:

- ▶ 2019: Convene Salary Setting Commission
