<u>Friendly Amendment</u>: Vice Mayor Rosemary Kamei requested that staff look into a potential pilot utilizing or recruiting high school seniors that would enable them to become eligible to apply for crossing guards positions; to help fill the current vacancies as a possible solution.

Councilmember Pam Foley stated the friendly amendment was a separate item not in conjunction with the motion on the floor and suggested that it be included as part of Vision Zero Task Force focus discussion on the topic of crossing guards. Vice Mayor Rosemary Kamei accepted the request and retracted her friendly amendment.

(2) Direct Parks, Recreation and Neighborhood Services Department to pursue

private grants and sponsorships to fund non-personal costs for a third Viva Calle event. (3) Evaluate ways to ease and simplify the crossing guard application process to increase the number of completed submissions.(9-1-1; Noes: Mahan. Absent: Davis)

<u>Action</u>: Upon motion by Councilmember David Cohen, seconded by Councilmember Peter Ortiz, and carried unanimously, the staff recommendations were approved, (a) the findings were made related to the local geographical, topographical, climatic conditions and cost effectiveness, (b) **Ordinance No. 30950** was *passed for publication*, amending various sections of Chapter 24.12 of Title 24 (Technical Codes) of the San José Municipal Code; and (c) the City Manager or designee submitted a reach code submittal package to the California Energy Commission for its approval as required by law was authorized.
