SUBJECT: AMENDMENT OF THE MASTER AGREEMENT FOR SWA GROUP FOR LANDSCAPE ARCHITECTURE, ARCHITECTURE, ENVIRONMENTAL, AND ENGINEERING SERVICES

# **RECOMMENDATION**

Adopt a resolution authorizing the City Manager or designee to negotiate and execute a second amendment to the Master Agreement with Sasaki, Walker, and Associates Group for landscape architecture, architecture, environmental, and engineering consulting services, in order to increase the overall compensation by \$500,000, from \$1,500,000 to \$2,000,000, to complete active projects and extend the agreement from April 8, 2023 to December 31, 2025.

#### **OUTCOME**

Approval of the amendment for the consultant services allows the City to continue to use Sasaki, Walker, and Associates (SWA) Group for the development of downtown park sites: North San Pedro Park and Bassett Park. Amending the Master Agreement allows the City to continue its relationship with SWA Group to support the Parks, Recreation and Neighborhood Services Department (Department) and Public Works Department in administering the design, environmental, bid and award, and construction phases of the projects based upon the Master Plan for the parks.

#### **BACKGROUND**

On October 2, 2017, the Department released a Request For Qualifications for *Comprehensive Capital Improvement Program Consultant Services* with the intent to hire multiple firms to support future project delivery from planning through construction. The process supported the hiring of one or more firms, with a maximum compensation of \$3,750,000. In April 2018, the

City Council authorized the City Manager<sup>1</sup> to negotiate and execute Master Agreements with five consultants for Capital Improvement Program services for \$750,000 each.

The City Manager negotiated five Master Agreements with the selected firms, including SWA Group. Each agreement was for a five-year term, at a maximum compensation of \$750,000. For SWA Group, the five-year contract term started June 8, 2018 and will end April 8, 2023.

The first authorized amendment increased the maximum total compensation from \$750,000 to \$1,500,000. Three park development projects were bundled together for master planning through construction under contract with SWA Group: Pellier Park, North San Pedro Park, and Basset Park. SWA Group is currently working on the design phase for North San Pedro Park and Basset Park projects which require additional support and services to ensure successful project completion. Pellier Park is in its final stages of construction and will be completed in early 2023.

#### **ANALYSIS**

Staff engaged firms through the issuance of negotiated service orders, based upon the authority granted by the Master Agreements. SWA Group's first service order was used to create a Master Plan for three parks in the downtown area. Subsequent service orders were used for design development.

Increasing the Master Agreement with SWA Group from \$1,5000,000 to \$2,000,000 allows the firm to support the Department and Department of Public Works in completing the design and construction of the two remaining parks: North San Pedro and Basset. Using SWA Group for the design phase provides important consistency and continuity for the three projects and ensures the community feedback is reflected clearly in the projects to be constructed.

While the City could contract work to one of the other four consultants per the Master Agreement, the Department believes that assigning the additional work to SWA Group is cost-efficient and provides continuity from the Master Plan through construction. Using other consultants from the approved Master Agreement list is not recommended. SWA is currently finalizing the bid set of construction drawings. The firm will support design work based on the knowledge gained from the development of Master Plans, the CEQA related work, and direct knowledge of community input.

This action will not impact the existing agreements with the four other consultants.
