RECOMMENDATION

Set a City Council Study Session entitled *The Cost of Residential Development in San José* for Thursday, October 26, 2023, from 1:30 p.m. -4:30 p.m. in the Council Chambers and approve the Study Session agenda.

PURPOSE

The purpose of the Study Session is to provide the City Council with an updated report on the cost of residential development. The report is comprised of two sets of analyses produced with the help of a consultant that evaluates the total cost of residential development in San José for market-rate and affordable housing.

OUTCOME

The information provided through the presentation will help inform the City Council as it considers future program and policy changes to help deliver on the City's housing goals.

BACKGROUND

The report on the cost of residential development has been an ongoing work item on the City's Housing Catalyst Work Plan. The City Council has received three previous reports in 2018, 2019, and 2022. The report has continued to be a valuable tool for understanding the factors, both within and outside the City's control, that influence the viability of new housing construction.

At the March 14, 2023, City Council meeting, during the discussion on item 8.1, Actions Related to the Loan Commitment and Land Purchase for 797 Almaden, a New Affordable Housing Development, the City Council requested a Study Session on the cost of affordable housing

development, including a comparison of the costs of different interim housing products and permanent supportive housing, as well as information on the pipeline of affordable housing projects. Housing Department staff indicated that a Study Session could be conducted in August 2023. The Study Session was included in the City Council's action on the 797 Almaden New Affordable Housing Development project.

Given the complexities of affordable housing development and the strategies included in the recent City Council-adopted 2023-2031 Housing Element, staff designed a two-part Study Session in response to the City Council request. The Part 1 Study Session, entitled *Affordable Housing Strategies: Production, Preservation, and Protection (3Ps of affordable housing),* was held on September 7, 2023. It provided the foundation of the 3Ps of affordable housing and featured panel presentations from housing funders and practitioners.

ANALYSIS

The Cost of Residential Development in San José Study Session agenda accompanies this memorandum. The City Council and participants will be provided with background information to help frame the discussion. The format will include a presentation from staff and consultants, panel presentation, and City Council discussion followed by public comment. The Study Session is informational and no action by the City Council is requested.

COORDINATION

This memorandum was coordinated with the City Attorney's Office.

• Environmental and Utility Services - Manage environmental services and utility systems to ensure a sustainable environment for the community.

• Community & Economic Development - Manage the growth and change of the community in order to create and preserve healthy neighborhoods and ensure a diverse range of employment and housing opportunities.

You may speak to the City Council about any discussion item that is on the agenda, and you may also speak during Open Forum on items that are not on the agenda and are within the subject matter jurisdiction of the City Council or Successor Agency to the Redevelopment Agency Board. If you wish to speak to the City Council, please refer to the following guidelines:

• Fill out a Yellow Speaker's Card and submit it to the City Clerk seated at the front table. Do this before the meeting or before the item is heard. This will ensure that the name on the card is called for the item(s) that you wish to address, and it will help ensure the meeting runs smoothly for all participants by calling speakers in an orderly manner.

• When the Council reaches your item on the agenda, the Mayor will open the public hearing and call your name. Please address the Council from the podium, which is located to the left of the City Clerk's table.

• Each speaker generally has two minutes to speak per item. The total amount of time allocated for public testimony for each public speakers or for an agenda item may be limited

at the Mayor's discretion, depending on the number of speakers or the length of the agenda. (California Government Code Section 54954.3; Council Policy 0-37)

• To assist you in tracking your speaking time, there is a display on the podium. The green light turns on when you begin speaking; the yellow light turns on when you have 30 seconds left; and the red light turns on when your speaking time is up.

Please be advised that, by law, the City Council is unable to discuss or take action on issues presented during Open Forum. According to State Law (the Brown Act) items must first be noticed on the agenda before any discussion or action.

The San José City Council meets every Tuesday at 1:30 p.m. and Tuesday at 6 p.m. as needed, unless otherwise noted. The City Council, or less than a quorum, may adjourn any regular, special or adjourned meeting to a later date, time and place specified in the order of adjournment. If all members are absent, the City Clerk may declare the meeting adjourned to a stated date, time and place. If you have any questions, please direct them to the City Clerk's staff seated at the tables just below the dais. Thank you for taking the time to attend today's meeting. We look forward to seeing you at future meetings.
