RECOMMENDATION

1. Approve the College Football Playoff 100 days to playoff scheduled on 9/28/18 as a City Council sponsored Special Event and approve the expenditure of funds.
2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
3. Place the item on the 9/26/18 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The 100 Days to the College Football Playoffs flag raising will be held on Friday, September 28, 2018 at San Jose City Hall Plaza and sponsored by Councilmember Dev Davis. This special event 100 days to the College Football Playoffs event is free and open to the public.

The display of the College Football Playoff Flag on September 28, 2018 is permitted under Council Policy 2-1, C.2 – Flags Displayed in Conjunction with Official Ceremonial Items: “Other flags may be displayed in conjunction with official actions, ceremonial items, or proclamations of the City Council.” The 100 Days to the College Football Playoffs Proclamation will be presented at the September 25, 2018 City Council meeting.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Dev Davis will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 6, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
